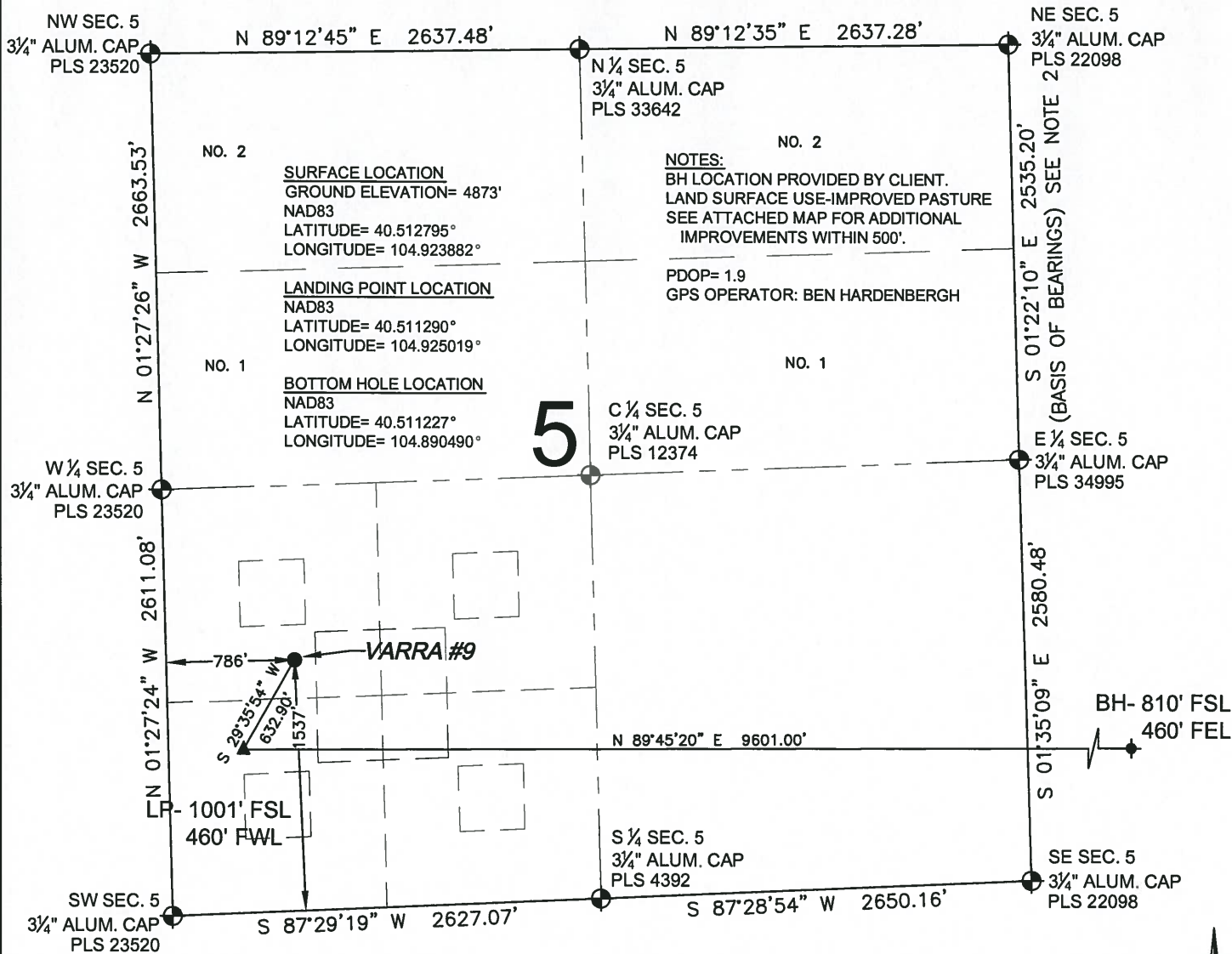
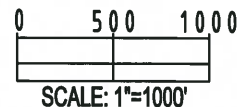


WELL LOCATION CERTIFICATE: VARRA #9

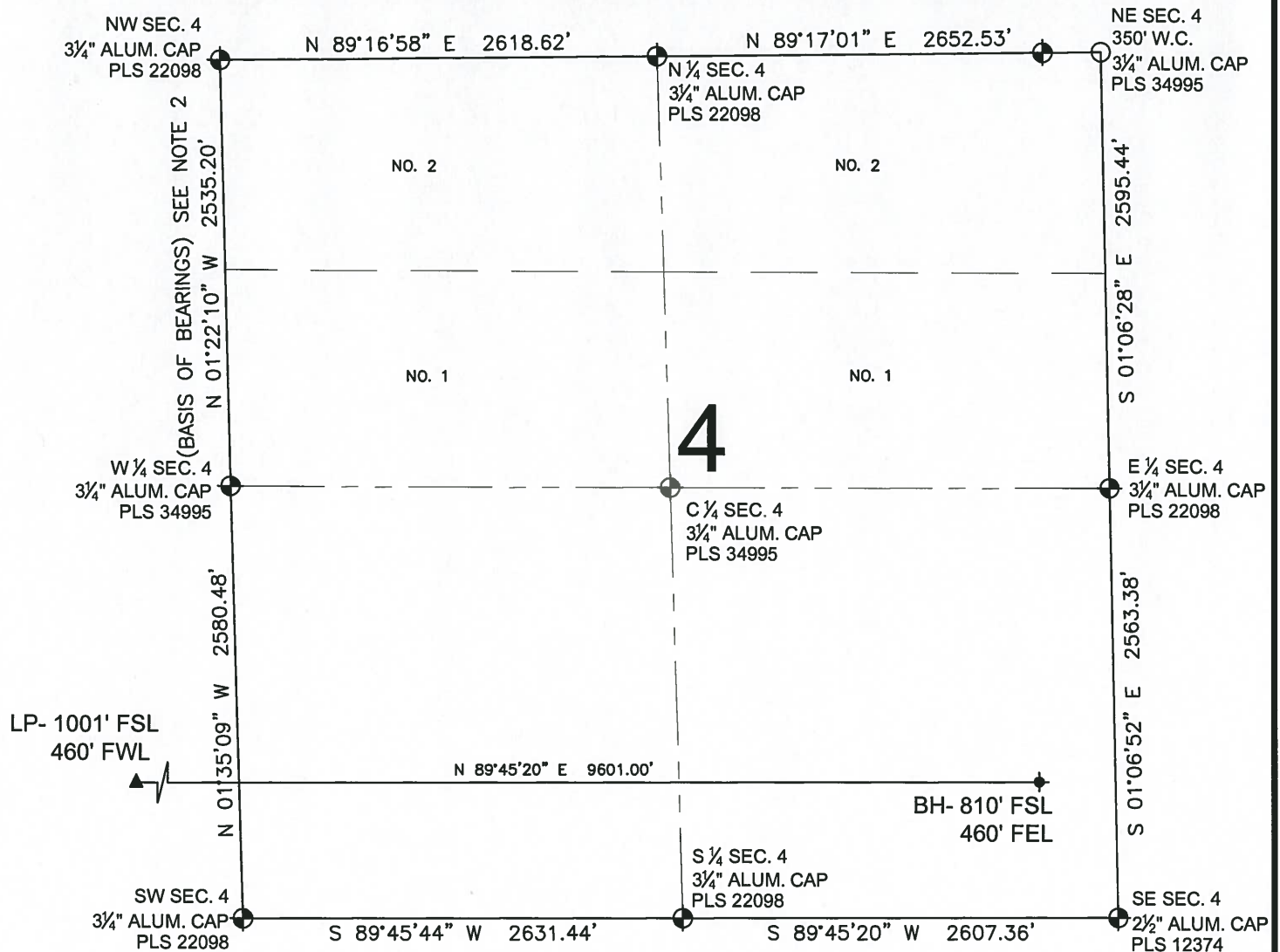
