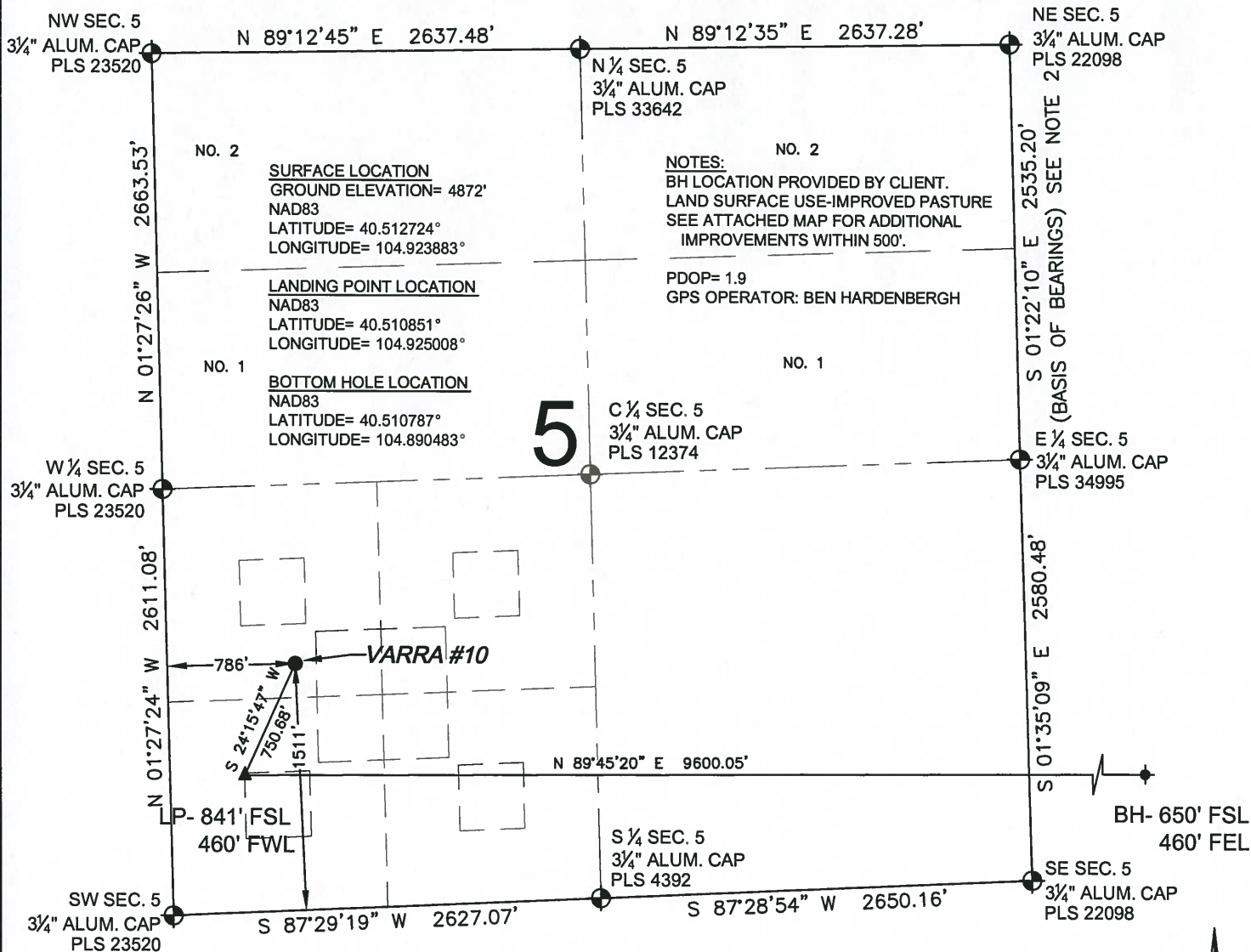


WELL LOCATION CERTIFICATE: VARRA #10

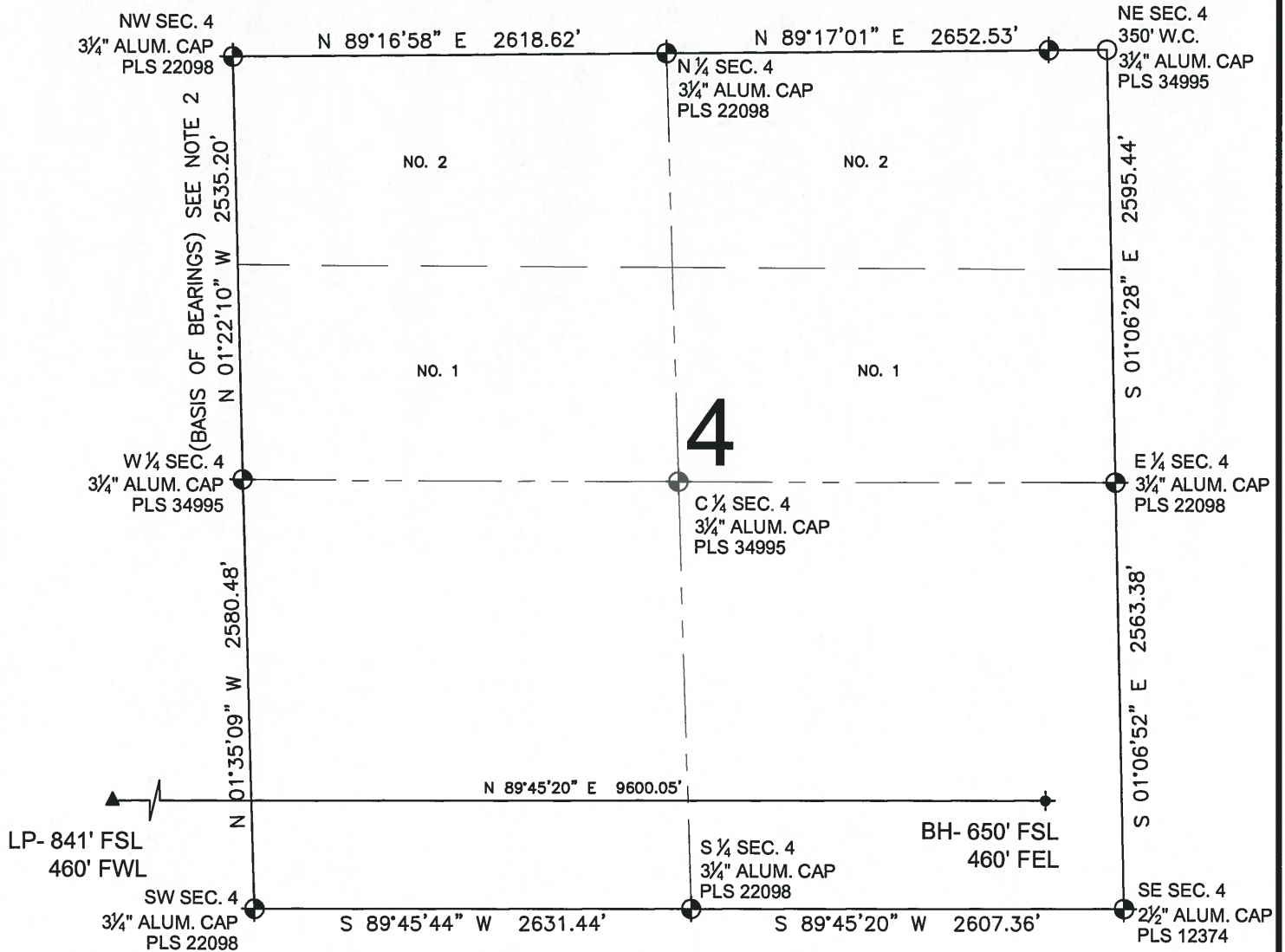
