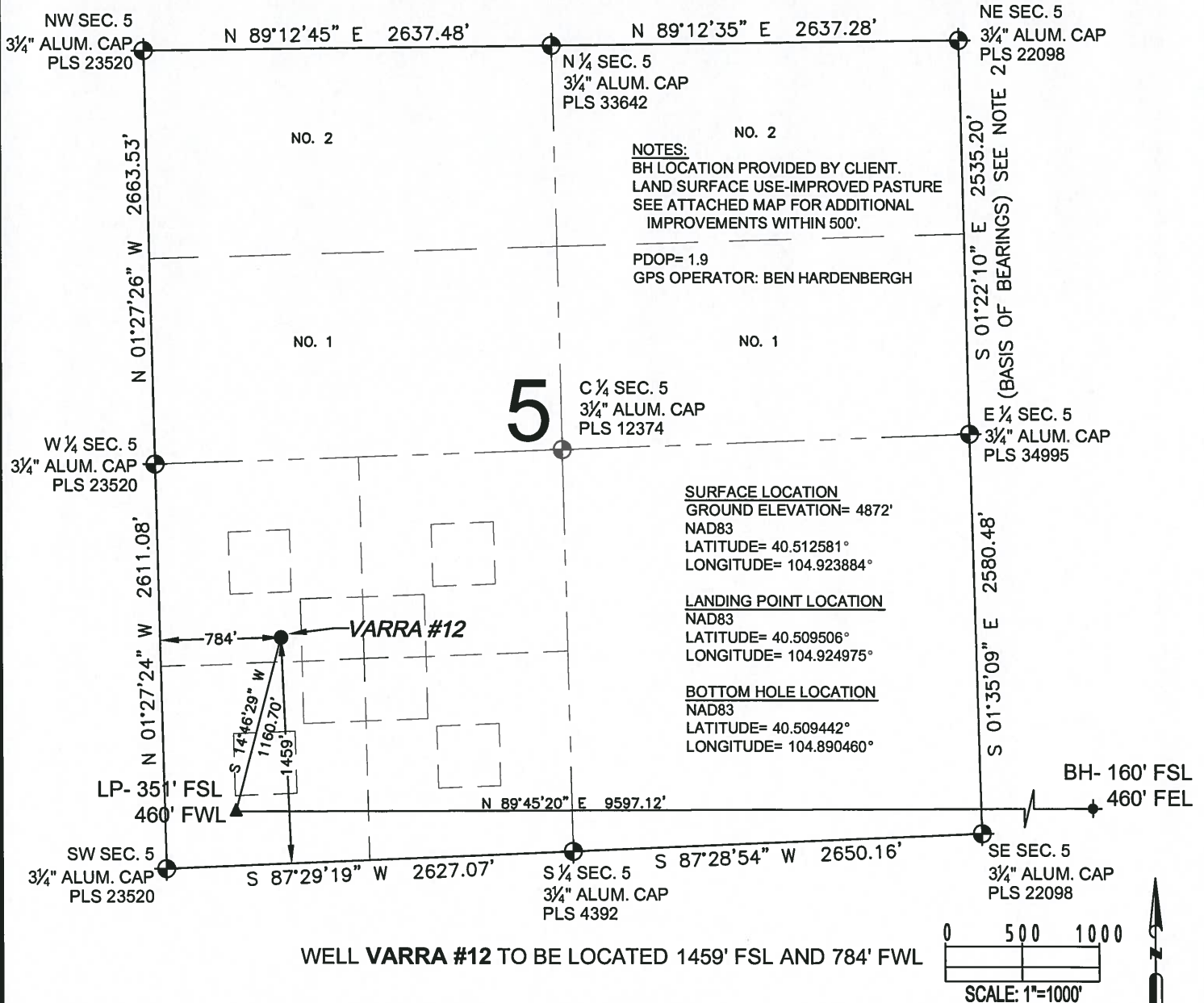


WELL LOCATION CERTIFICATE: VARRA #12

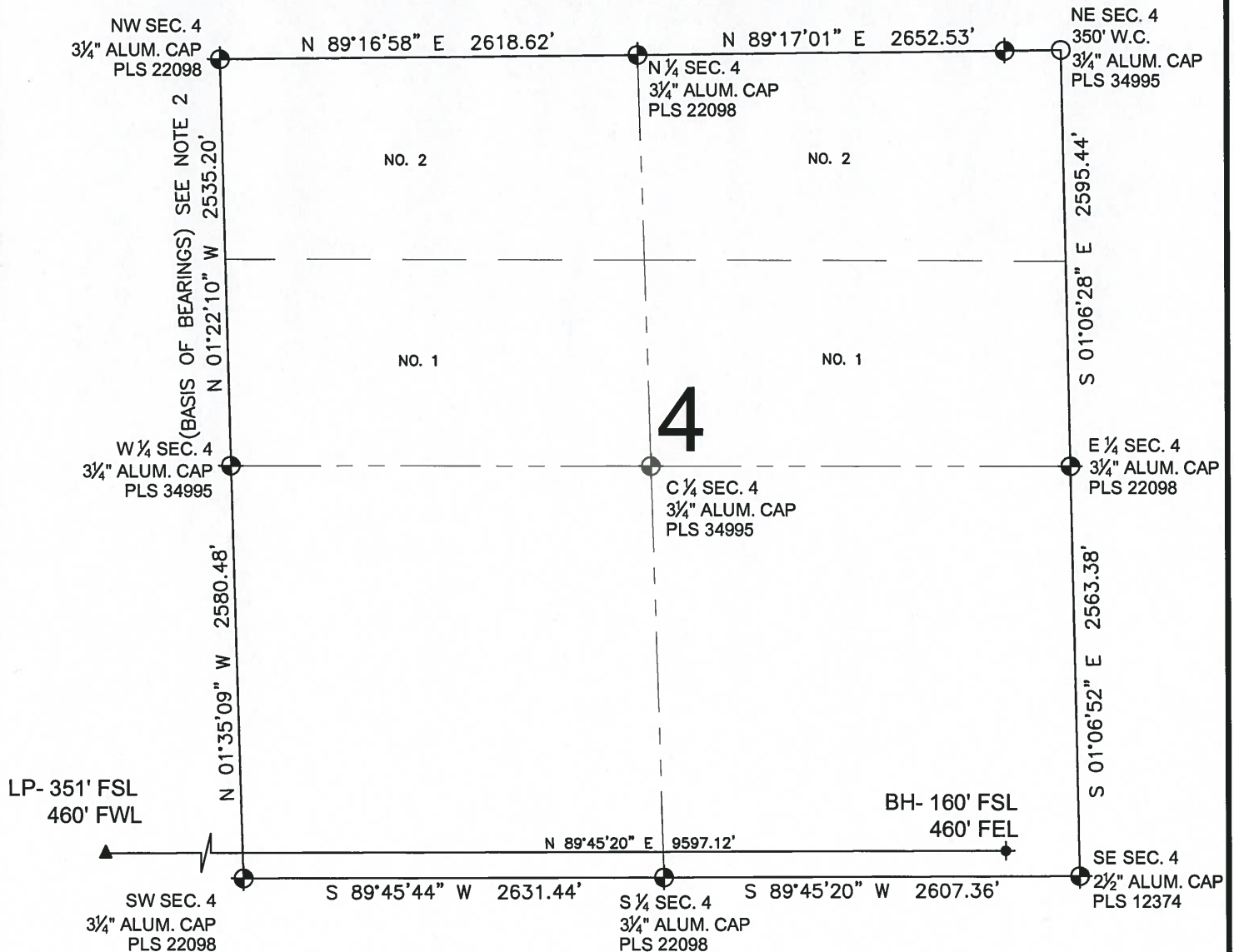

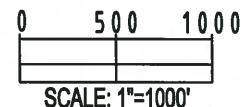
