NEI would like to add 1 VRT to this location. The addition of the equipment is to reduce possible flash vapors to abide by air permitting rules as well as a safety precaution. The equipment addition will be within the permitted facility location, Doc 400262138, approved 8/10/13. Documentation submitted with the approved 2A is still viable other than the pictures since the location has been constructed. The location is in cropland, NRCS Map 29, Julesburg Sandy Loam, 0-1% slope, NRCS Map 72, Vona loamy sand 0-3% slope. An updated equipment inventory list is attached which includes previous equipment additions.
