OPERATOR COMMENTS AND SUBMITTAL

Comments Drilled down to 6,222 ft. Made several attempts to establish good build rates with changing out BHA. The more of the well that was drilled the further we got behind the planned curve. When we found the A-chalk 50 degree doglegs were needed to reach the target. It was then decided to plug pack the well and make another run at the curve.

The well was drilled to a depth of 6,222 feet.

9 5/8" 36.00 ppf J-55 ST&C casing was set to a depth of 467 feet.

There is not a fish in the hole

A plug was set from 5,722' to 6,222 feet, with 200 sacks of 17.50 ppg slurry with additives resulting in a 1.11 cu ft./sk yield.

The well will be kicked off at approximately 5,700 feet.

This sidetrack will continue to target the Niobrara Formation.

The BHL will remain as originally permitted, 470' FNL and 1991' FEL.

The sidetrack plan was approved by e-mail by Diana Burn; a copy of this correspondence has been attached.
