You need to sample the area where the impacted soils were removed and demonstrate the excavated area meets Table 910-1 standards before you can backfill with any clean dirt. Please ensure you GPS the sample locations and analyze for all Table

910-1 soils constituents.

I have not seen the original soil samples (if available) from this spill so cannot approve a reduced sampling list until those data are provided so the COGCC can be assured of what constituents were non-detect in the original spill vs. those that were either detected or above standard.
