## OPERATOR COMMENTS AND SUBMITTAL

Comments BBC is submitting this form 2 for an unplanned sidetrack. The rig was tripping out of the hole to re-arrange the BHA when the bit depth got changed to an incorrect value. We tripped back to bottom and thought we were off bottom but in reality we were drilling new hole. Total measured depth reached in the wellbore being plugged back – 11,794' MD. Casing set – size(s) and measured depth(s) - 9 5/8 Surface csg @ 842' and 7" intermediate @ 6,759' MD. There's no fish in the hole. This will be open hole sidetrack, no cement. Measured depth of proposed sidetrack kick-off point – 11,578' MD. Proposed objective formation(s) for sidetrack hole is the same as the original hole. BHL target is the same as the original hole. Diana Burn provided approval to sidetrack today 6/17/14.
