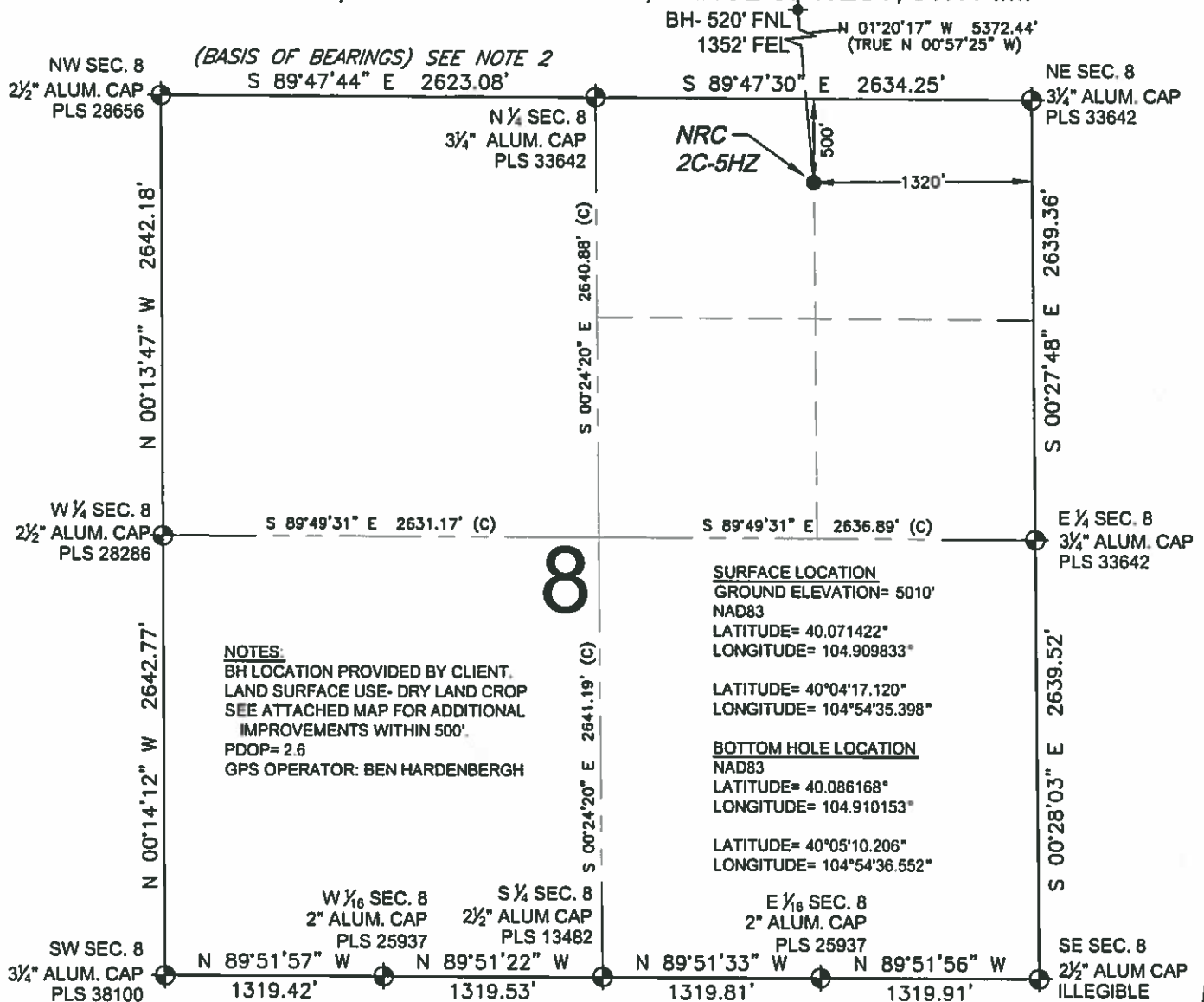


WELL LOCATION CERTIFICATE: NRC 2C-5HZ

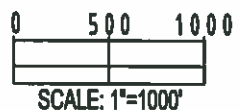

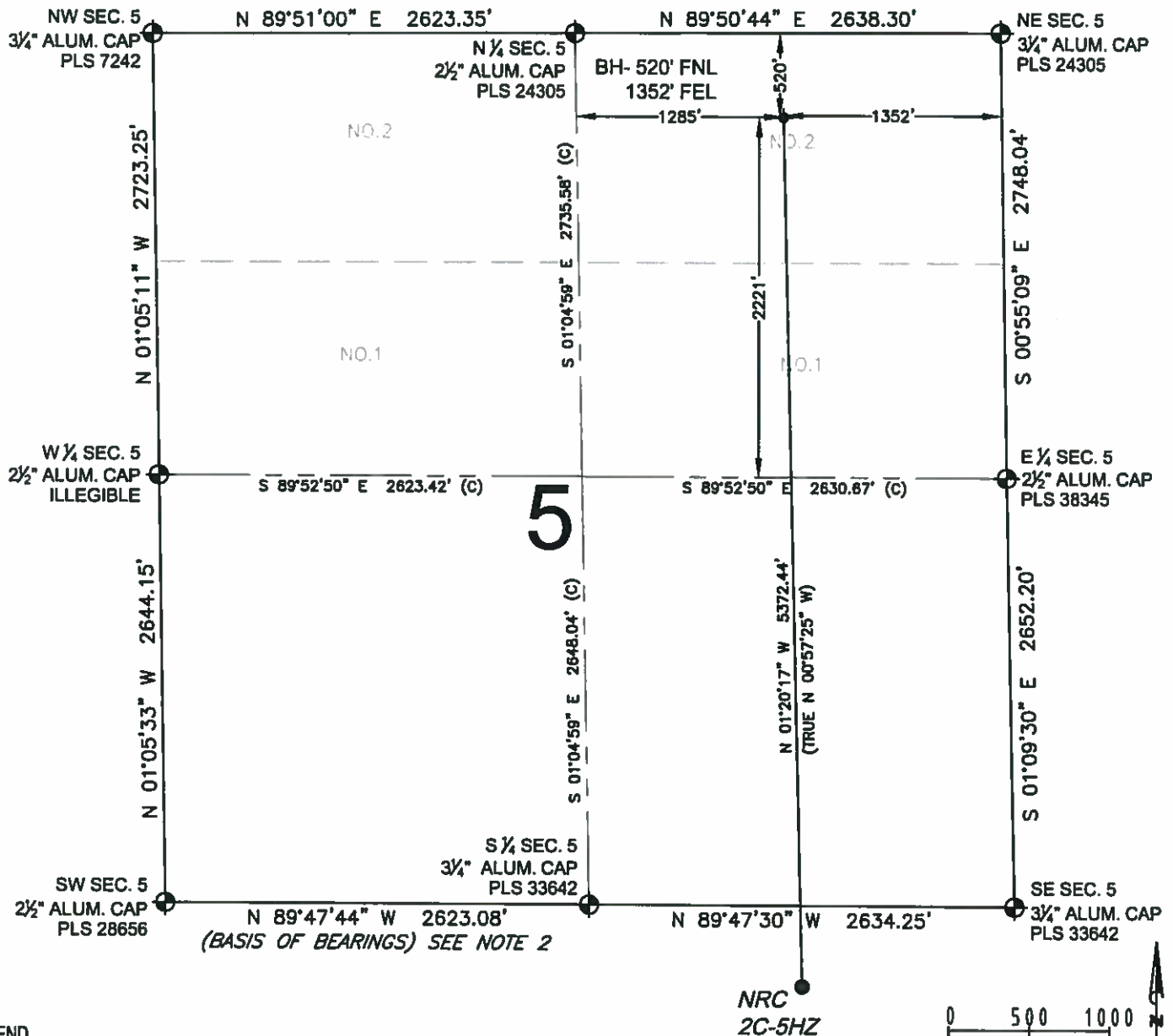
