WPX Energy encountered tight hole conditions while running casing. We were able to make 3 inches progress in 3 hours, then no forward progress was possible. The 9 5/8" casing was at 1056' MD, 997' TVD. The casing is set 77' MD shallower then expected.

The well was originally permitted for 9 5/8" – 1133' MD, 1057' TVD.
