PDC Energy ("PDC") intends to drill and produce the above referenced horizontal oil and gas well(s), to be located as described above. PDC respectfully requests the Director to approve an exception to Rule 317.o for the referenced proposed wells, as suitable gamma ray and resistivity logs exist in the records from prior wells drilled in the vicinity of the surface- hole location of the proposed new well(s).


The logs from the following prior-drilled well are proposed to provide adequate log coverage to characterize the geology of the area.

CBL and gamma logs will be run on the 7" first string, from the top of the curve to surface, on the proposed new well(s), and submitted to COGCC. The horizontal portion of each well on the pad will be logged with a measured-while-drilling Gamma Ray. The Drilling Completion Report- Form 5 submitted for each well will indicate that no open-hole logs were run. PDC hereby requests the Director to grant an exception to Rule 317.o.
