In accordance with landowner approval, excess material on the J-13 pad that requires landfarming to decrease contaminant concentrations below the Table 910-1 standards will occur on the LINN Energy I-11 pad. Due to previous interim reclamation work on the J-13 pad that revealed the existence of this material, and the reclaimed location's decreased size, material will be hauled off-site to the I-11 pad where landfarming will take place. Periodic soil sampling will be conducted to monitor landfarming efforts and determine when backfilling can begin. It is estimated that landfarming activities will last for approximately 2 years, depending on soil and weather conditions. Once clean, this material will be returned to the original location found on the J13 and covered with 3' of clean material.

Composite samples should be taken from a grid and be statistically representative of the material in the cell(s). 6) Report to COGCC when landfarming operation is complete and indicate final disposition of landfarmed material.
