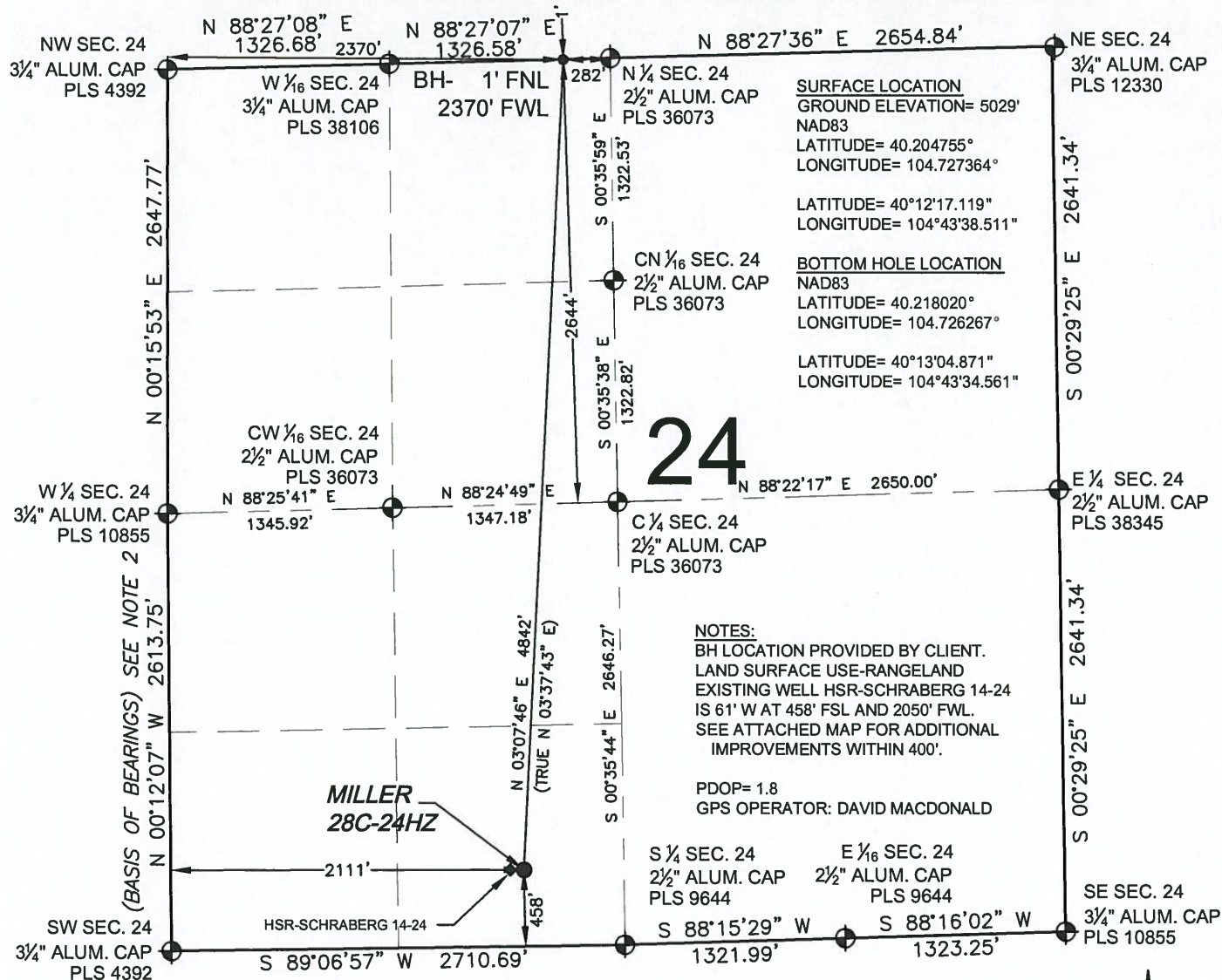


WELL LOCATION CERTIFICATE: MILLER 28C-24HZ

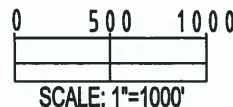

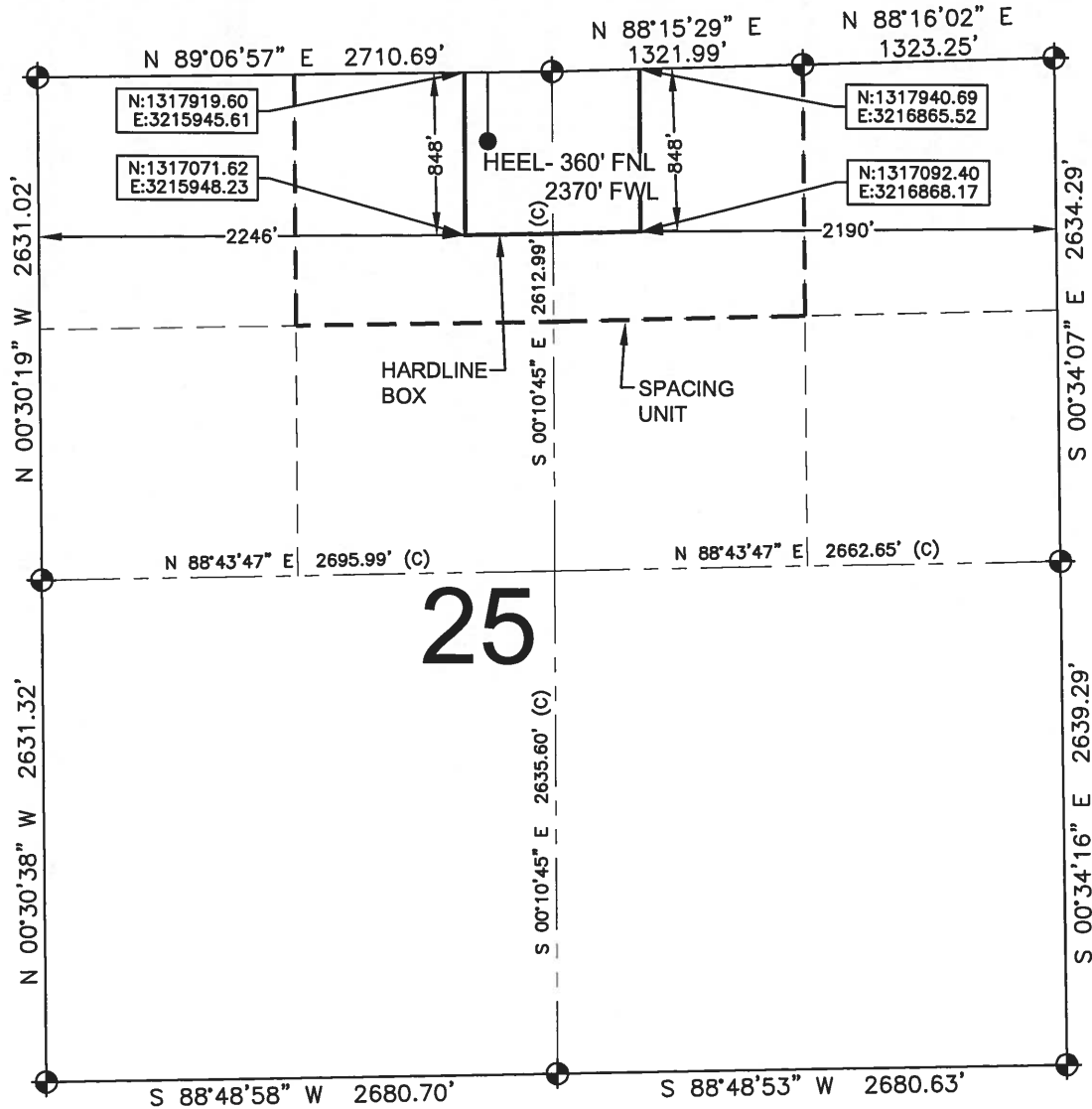
