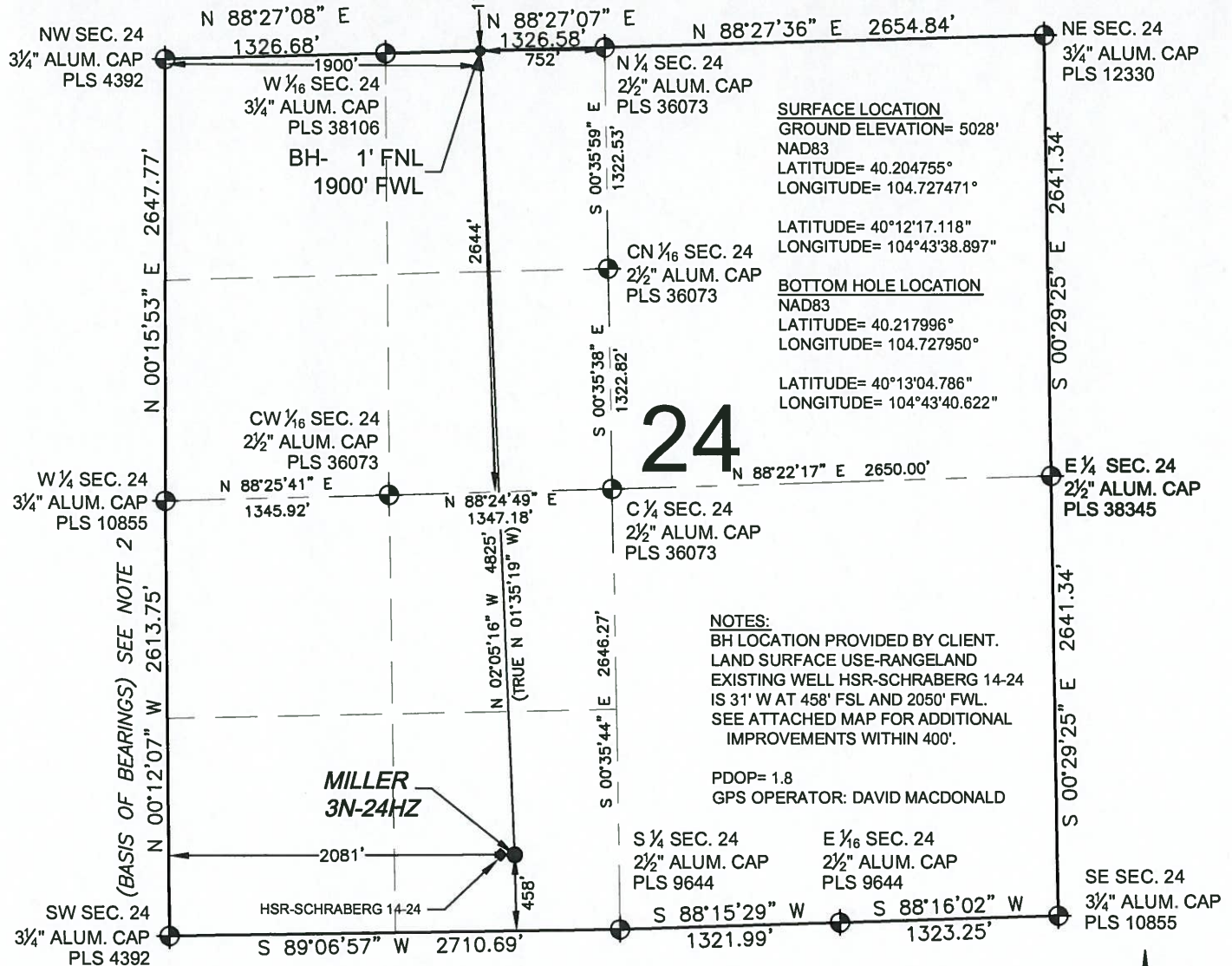


WELL LOCATION CERTIFICATE: MILLER 3N-24HZ

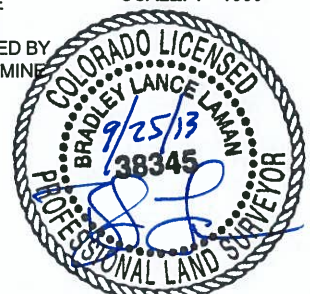

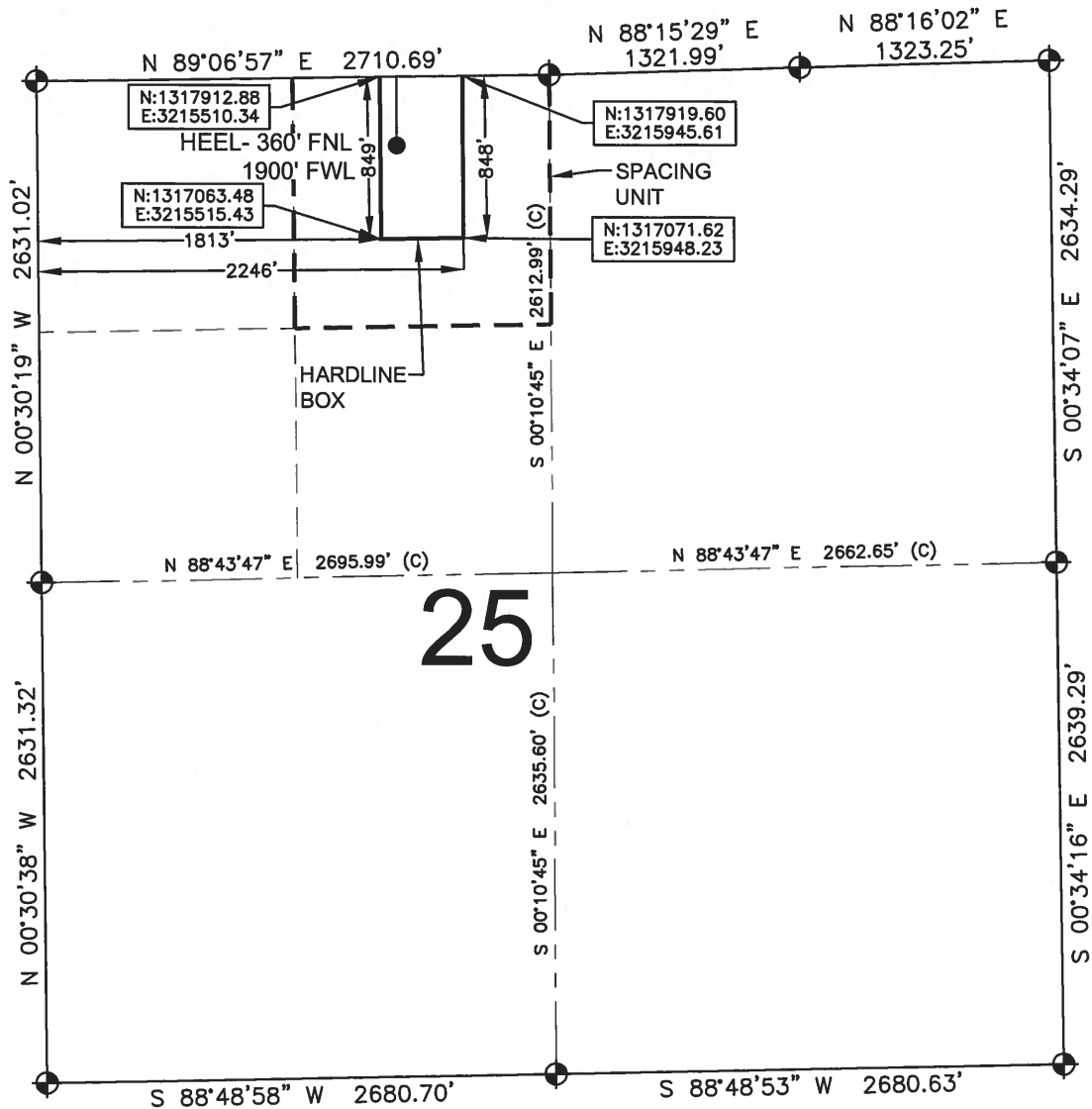
