

15. Ponds are $\pm 445'$ W, and $\pm 502'$ NW.
16. Canal is $\pm 442'$ S.
17. Concrete Ditches are $\pm 609'$ NW, and $\pm 953'$ NW.
18. Underground Water Lines are $\pm 862'$ NE, and $\pm 864'$ NE.
19. Water Well (Permit # 246095) is $\pm 758'$ NE.
20. Water Well (Permit # 246095) is $\pm 835'$ NE.
21. Water Well (Permit # 246129) is $\pm 1051'$ NW.
