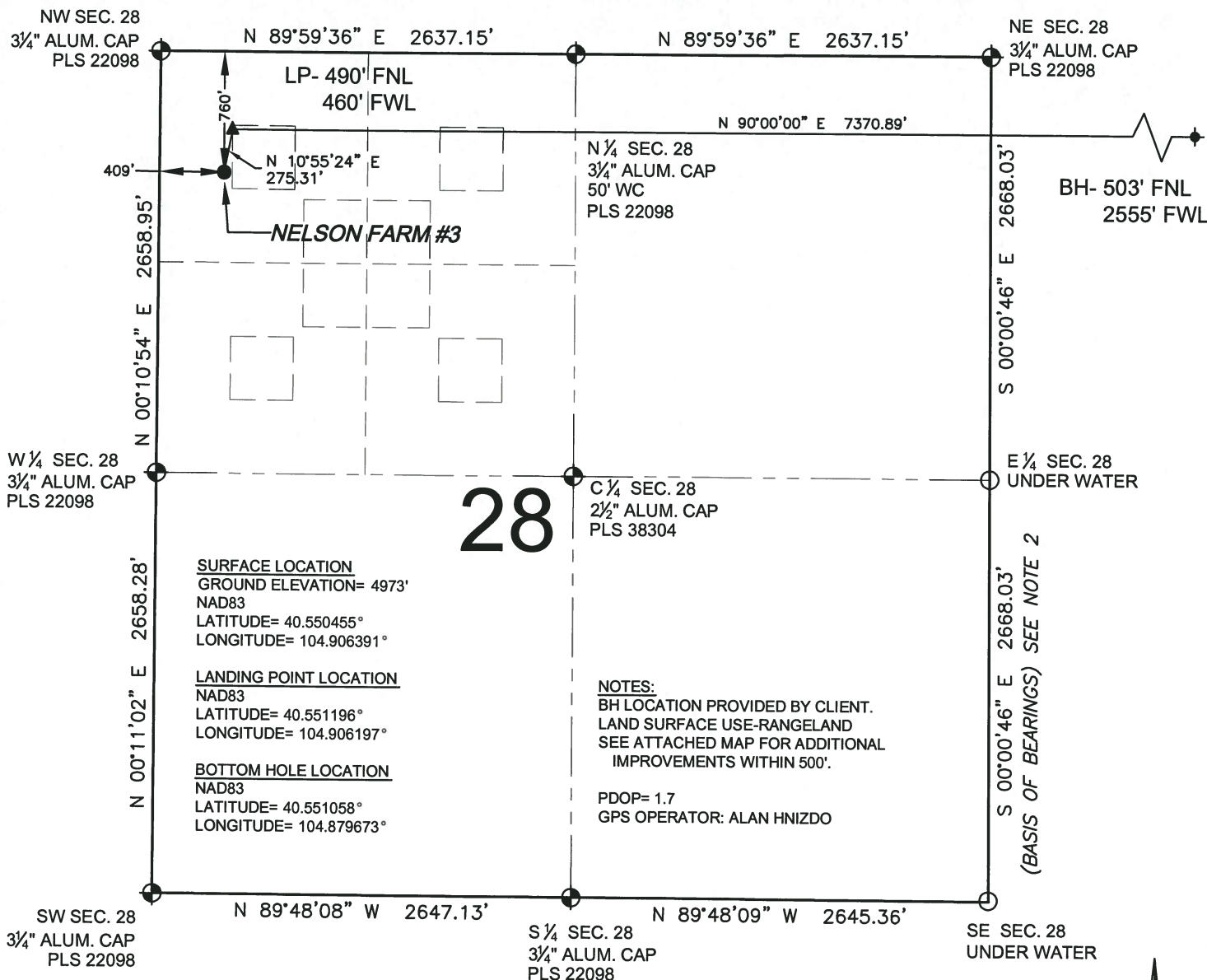


# WELL LOCATION CERTIFICATE: NELSON FARM #3

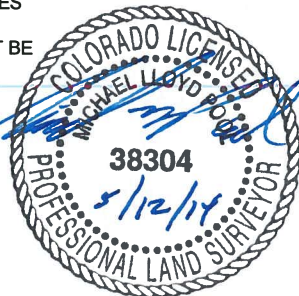

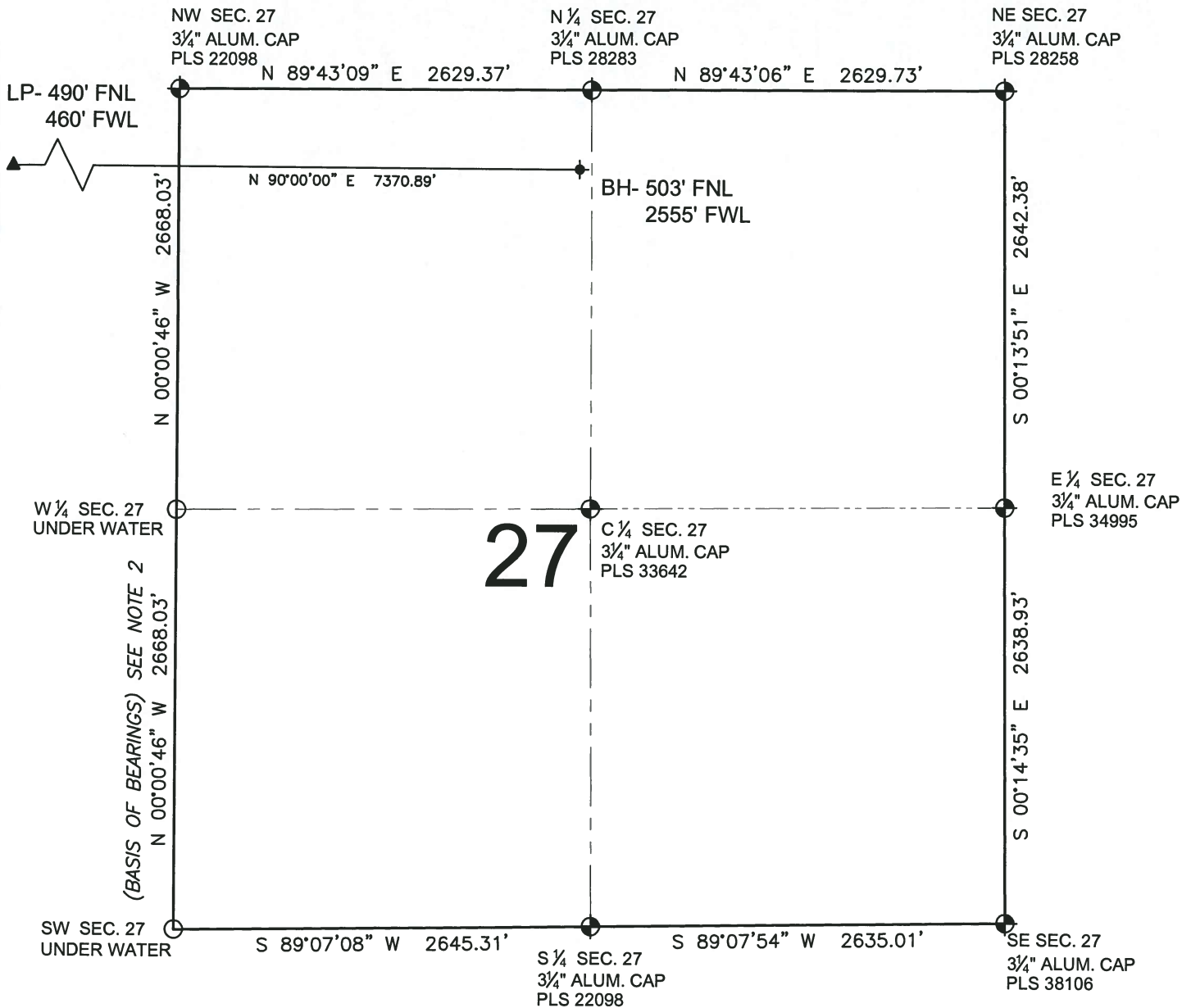

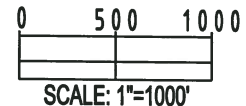
