COMMENTS:

This North Fork 42-12 well was purchased by Southwestern ("SWN") from SWEPI, May 2014 and has been SI for 2 years. SWEPI had a MIT extionsion in place, Form 4 #400587490, due to expire 6/30/14. The well currently has 2160 CP and a separator and tank batteries are in place. The well is currently still connected to the pipeline. SWN would like the open the well and flow back. SWN plans to flow the well into sales instead of flaring the produced gas. If the well proves not commercail by July 14, 2014, SWN will commit to temporary abandonment. A rig is scheduled July 14, 2014, if needed. The TA operation plan is to pump a remedial squeeze job across the perfs at 7950' and set a RBP 50' above top perf. SWN will then perform a MIT.
