ACCESS ROAD MAP **TOPO B**

PROCEED IN A SOUTHERLY, THEN SOUTHWESTERLY DIRECTION FROM BRIGGSDALE, COLORADO ALONG HIGHWAY 392 APPROXIMATELY 9.7 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 74 TO THE EAST; TURN LEFT AND PROCEED IN AN EASTERLY DIRECTION APPROXIMATELY 7.1 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 83 TO THE SOUTH; TURN RIGHT AND PROCEED IN A SOUTHERLY DIRECTION APPROXIMATELY 3.0 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 68 TO THE WEST; TURN RIGHT AND PROCEED IN A WESTERLY DIRECTION APPROXIMATELY 2.0 MILES TO THE BEGINNING OF THE PROPOSED ACCESS FOR THE WILL 6-62-15_22 NENW PAD TO THE NORTH; FOLLOW ROAD FLAGS IN A NORTHERLY, THEN EASTERLY DIRECTION APPROXIMATELY 6,683' TO THE BEGINNING OF THE PROPOSED ACCESS ROAD TO THE SOUTH; FOLLOW ROAD FLAGS IN A SOUTHERLY DIRECTION APPROXIMATELY 136' TO THE PROPOSED LOCATION.
