THIS LOCATION WAS APPROVED BY THE BLM ON 06/25/09. WE MOVED THE ACCESS ROAD FOR OUR FIRST WELL BIG HOLE GULCH UNIT #1 TO AVOID A SAGE GROUSE LEAK TO THE SOUTH. THIS NEW PROPOSED WELL LOCATION AND ACCESS ROAD ARE OUT OF THE SAGE GROUSE LEAK. YATES WOULD THINK THAT THE RSFO AND SWHA AREAS HAVE BEEN PROTECTED ALREADY BY THE SUFACE OWNER BLM. WE HAVE A TIME STIP FOR SAGE GROUSE NESTING 3/1 TO 6/30 THAT WE FULLY ENFORCE. DUE TO WINTER COMING AND 03/01/2110 MOVING CLOSER YATES RESPECTFULLY ASKS THAT THE 40 DAY WILDLIFE CONSULTATION BE SWIFT AND THE STATE OF COLORADO MOVE WITH THE MEASURES ALREADY IN EFFECT BY THE BLM.
