Description

Location is in a sensitive area because of close proximity to surface water; therefore, operator must ensure 110% secondary containment for any volume of fluids contained at well site during drilling and completion operations.

Location is in a sensitive area due to close proximity to surface water. Operator must implement best management practices to contain any unintentional release of fluids.

Location is in a sensitive area because of shallow groundwater; therefore, either a lined drilling pit or closed loop system is required.
