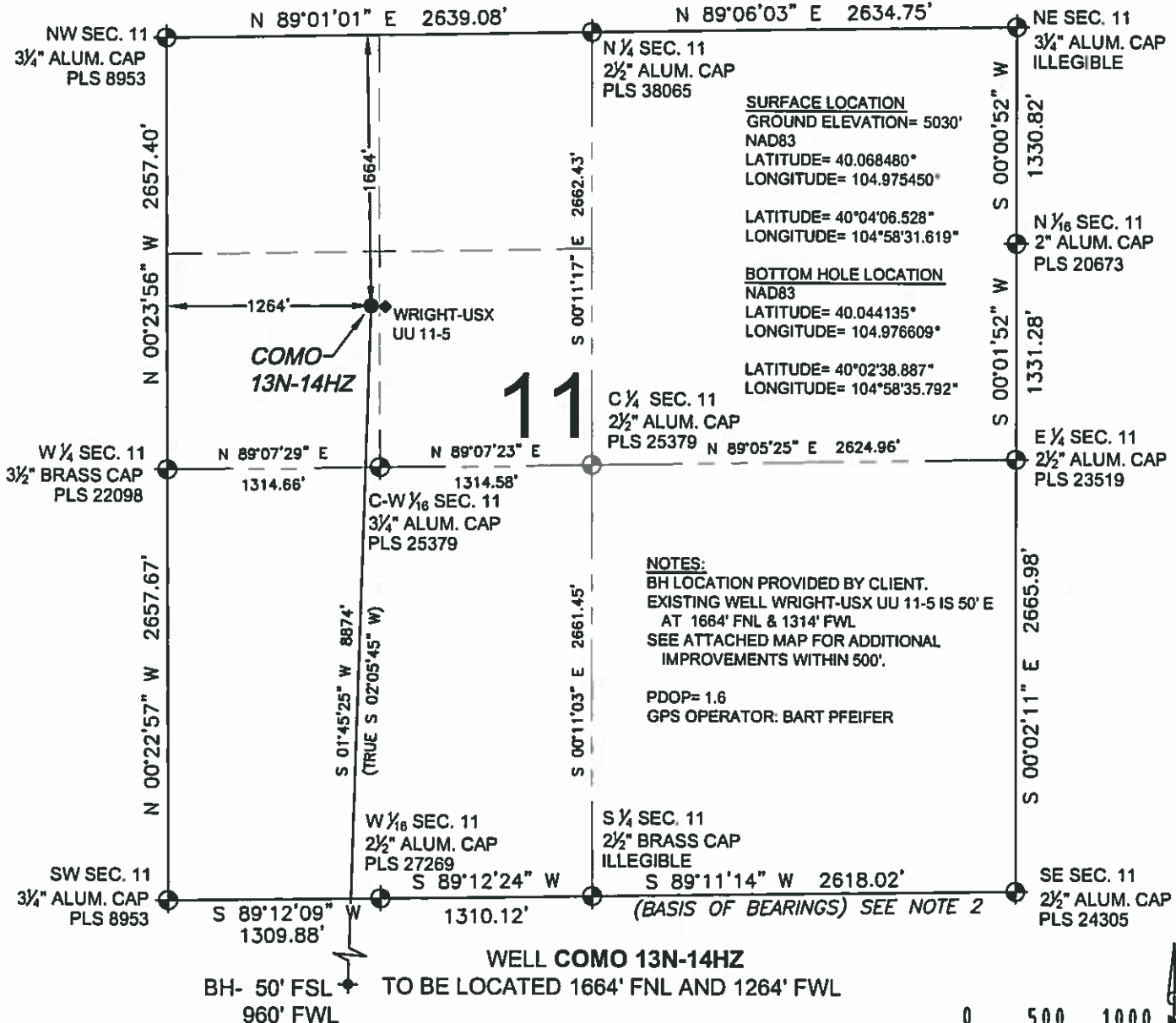


WELL LOCATION CERTIFICATE: COMO 13N-14HZ

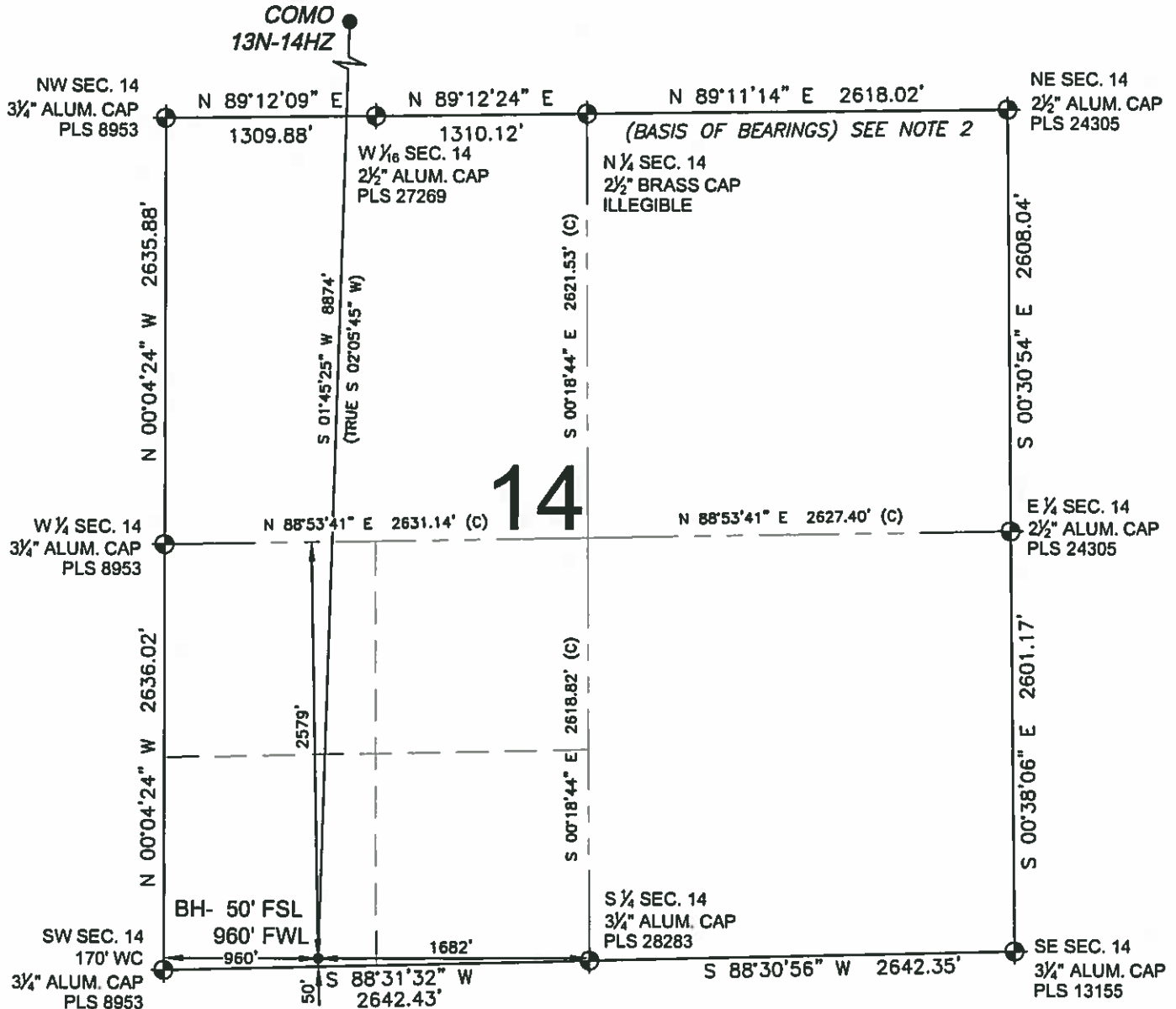

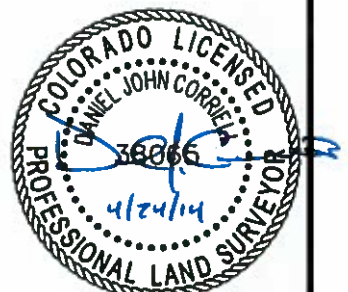
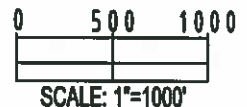
