The measurement does not reflect GPS measurement. The PDOP, instrument operator and date of measurement are bogus entries to allow e-forms to approve the values.

A dry-hole marker was not set.

These coordinates are from aerial photography. APC used (Bing), 2005 NAIP- 1m resolution (Where possible), and 2004 NAIP- 2m resolution. APC cross referenced this with the COGCC website. APC also verified using their stock imagery from the 1990's (Generally 98/99) and 2005 imagery (Around 1 ft resolution).
