Comments Ma-State # 12 well plugged and abandoned on 6-29-2014 due to lost hole. Unable to fish out 1898' of drill pipe which was left in hole.  
6-29-2014 Plugging Procedure - Ma-State 12 well. Set plug with 40 sks cement @ 4414'; set plug with 40 sks cement @ 4050'; set plug at 388' with 50 sks cement; 15 sks cement at surface; 5 sks cement rat hole; 5 sks cement mouse hole. Cut off surface casing 6' below surface.
