OPERATOR COMMENTS AND SUBMITTAL

Comments Encana requests the approval of a 318A.a.(1) and 318A.c(1) exception location as the well head is to be located outside of a GWA drilling window and further than 50' from an existing well. Request letter and waivers attached. This well is closer than 150' to the nearest permitted or producing BHL. A 318A.m. variance request letter and waivers are attached.

Encana requests the approval of the omission of open hole logs; request letter attached.

The distance from completed portion of the proposed wellbore to nearest wellbore permitted/completed in the same formation is the Newnam 2-32H C264, which is not yet permitted.

If current surveys do not exist for the offset wells, Operator may have gyro surveys conducted to verify bottomhole location. The proposed well will only be drilled if the anti-collision scan results indicate that there is not a risk for collision, or harm to people or the environment. For the proposed well, upon conclusion of drilling operations, an as-constructed gyro survey will be submitted to COGCC with the Form 5.</p>
