



Allison 12-22 is to be located at a point 2336' from the NORTH line and 310' from the WEST line, measured at right angles, of the NW Quarter of Section 22, Township 1 South, Range 44 West of the Sixth Principal Meridian, Yuma County, Colorado.

Latitude, Longitude, and Elevation are derived from RTK-GPS observations, and are based on published coordinates for NGS Station U385 MP234.73, located approximately 3 miles east of the proposed well location.

Distances shown hereon are at ground level and are field-measured.


