Elm Ridge Exploration Co LLC spud this well on 6-28-14. We drilled a 12 1/4" hole to 548'. We set 8 5/8" J55 STC 24# csg at 542'. We used 356 sks of cement with 20 bbls of good cement to surface. We reached a TD of 3656'. We set casing at 3643' on 7-4-14. We used 331 sks of lead cement and tailed in with 304 sks with 71 bbls of good cement to surface.
