2 MIRU Workover (WO) Rig. Control well with biocide treated water.

3 Set RBP at +/- 6,870'. Pressure test RBP to 1,000 psi

4 Run CBL to check current Sussex and Shannon formation coverage is adequate.

5 Unland 4-1/2" production casing and NU double entry flange.

6 Run in annulus to 1,250' with 1-1/4" tbq.

7 Mix & pump as follows: 241 sks Type III cement & 1/4 #/sk cello flake mixed at 14.8 ppg and yield of 1.33 cuft/sk (CaCl2 amounts as determined by cementing service company) for a total of 57.1 bbl of cement. Design is for adequate fox hills formation coverage.

8 TOOH with 1-1/4" tbq.

9 Re-land 4-1/2" production casing. Shut in and WOC for 24 hours minimum.

10 Run CBL to verify coverage meets requirements.

11 Pressure test casing to 5,000 psi.

12 Pull RBP.

13 Test wellhead to 5,000 psi

14 RDMO. Return well to production team.
