COGCC has reviewed the Form 27 Site Investigation and Remediation Workplan submitted by Foundation Energy Management, Inc. for the Sooner Unit 10-28 spill (tracking #2145522). The Form 27 has been approved with the following conditions:

1. *Submit a copy of the laboratory analytical report for the soil samples named WEST, NORTH, EAST, SOUTH, and BASE and collected on 7/19/2013.*
2. *Consult with the affected Surface Owner regarding surface reclamation plans in accordance with Rule 906.c.(2).*
3. *Conduct surface reclamation in accordance with Rule 1003.e.*
4. *Notify COGCC when reclamation of the affected area has been completed. The notice shall be given as described in Rule 1003.e.(3). Reference Remediation Project Number 8518 in the Reclamation Notice.*
