#### COMMENTS:

This is to notify the Colorado Oil and Gas Commission that Pioneer Natural Resources is proposing to do the following work on the San Pablo 11-4 WD well. 1. Obtain a commingled water sample from the Dakota, Purgatoire, Morrison and Entrada injection zones as a representative formation water sample of the intended injection zone. The aquifer exception request will contain representative analysis for Dakota-Purgatoire, Entrada. Morrison water quality will be inferred by resistivity log. 2. Perform step rate tests on the Dakota and Entrada zones to determine injectivity. 3. Complete the well with 3 1/2" tubing with the injection packer set at approximately 6095' (gross perforated interval of 6170' - 6818' with squeeze holes at 6125').
