As follows, From Ma-State # 4 well head, one 3" fiberglass pipeline approximately 1214' to a separator, from separator two 3" fiberglass pipelines approximately 100' to one 300 bbl oil tank and one 300 bbl water tank. Production equipment at Ma-State Tank Battery is shared with the Ma-State # 4,6 & 10 wells.
