The COGCC and LGD for Garfield County were notified of the H2S reading within 48 hours via email (7/21/14). Treatment was immediately added to the tank and it was rolled until the field meter indicated a reading of 0 ppm. Readings collected 50 feet away from the tank were 0 ppm.
