Julie,

Please provide documentation of Nobles attempts to contact water well owners for this well as required under Rule 318Ae(4)C.iii. The blanket statement of Noble sent 13 requests to sample is inadequate to determine if Noble has complied with Rule 318Ae(4).

This Sundry will be placed on hold until clear documentation has been received indicating:

1) Which water wells Noble evaluated for use as a Water Source under Rule 381Ae(4) and

2) Nobles attempts to contact the water well owners as required under Rule 318Ae(4)C.iii.

If adequate documentation is not received within five (5) business days the Sundry will be denied for failing to meet the documentation requirement under rule (318Ae(4)C.iii.
