Site visit: Site Assessment and Remediation Work Plan (REM # 8494) sampling event. Samples were taken on the North side of the pit, where liner has been damaged and patched; near the sump; outside of the fence on the North and East sides, where sediment from the pit perimeter was observed; and between the tank and the pit, on the Northwestern side of the pit. Bushes have been removed from the perimeter of the pit but there is still vegetation growing along the border of the pit. There is some erosion on the perimeter of the pit. The sediments, product of the erosion have been deposited outside of the fence. Evaporation pit is not in use.
