COMMENTS:

Whiting collected geologic data in the form of open hole logs and sidewall core samples in this vertical well prior to its required mitigation due to the DJ Basin Horizontal Offset Well Policy. After drill/clean out of the wellbore we ran a triple combo log, then ran in with a rotary sidewall core tool and collect samples in the following 10 depth intervals: 6642-6636, 6467-6461, 6435-6429, 6215-6211, 6140-6135, 6030-6023, 5981-5976, 5907-5902, 5832-5826, 5745-5737. Following the collection of logs and core samples we continued with the mitigation of the well (submitted a Form 6 - doc#400625326).
