**COMMENTS:**

The COGCC and LGD for Garfield County were notified immediately of the H2S reading (7/2/14). Additional treatment was added to the tank and it was rolled until the field meter indicated a reading of 0 ppm. Measurements collected 50 feet away from the tank were 0 ppm.
