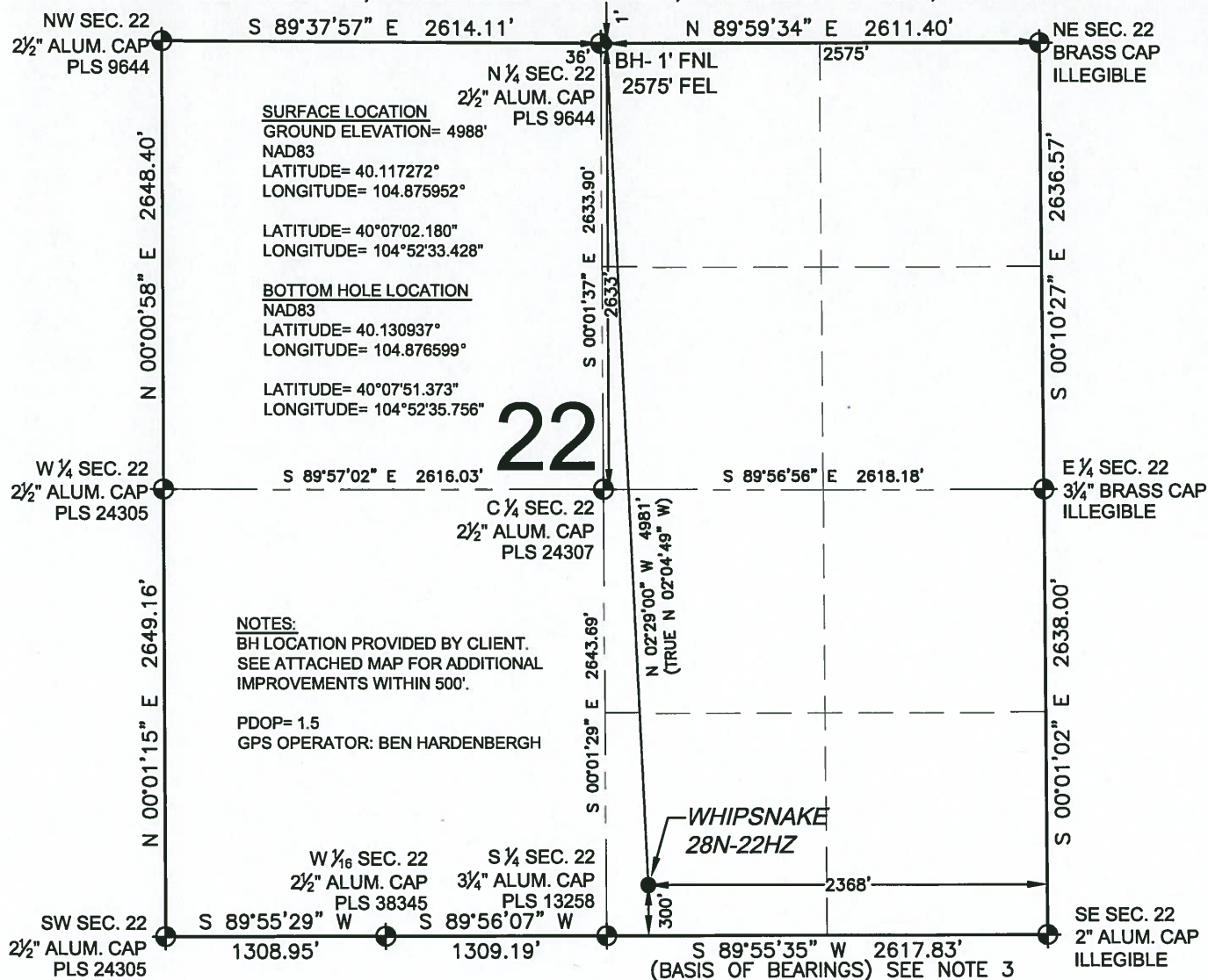


WELL LOCATION CERTIFICATE: WHIPSNAKE 28N-22HZ

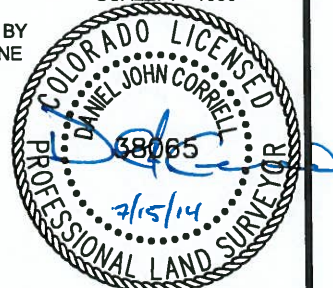
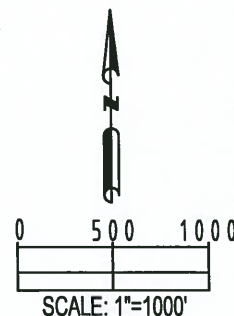
