- 1 MIRUSU. Kill well as necessary with water and biocide. ND wellhead. NU BOP.
- 2 POOH and stand back tubing.
- 3 MIRU WL. RIH with CCL and CIBP. Set CIBP at 7250'. POOH.
- 4 Shoot squeeze holes at 7050'- 7051' and at 6800' – 6801', using 3 SPF, 6 total shots.
- 5 RIH and set CICR at 6840'.
- 6 Prepare & pump cement. Design to provide an additional 250' of cement above Niobrara. Displace cement past the cement retainer to 6840'.
- 7 WOC overnight.
- 8 Run CBL to confirm coverage.
- 9 TIH with 3-7/8" bit on 2-3/8" TBG. Drill through cement and CICR down to CIBP at 7250'. Pressure test squeeze perforations to 1000 psi for 15 mins. If pressure test passes, proceed.
- 10 Continue to drill out to PBTD of 8102'.
- 11 TOOH while standing back tubing and LD bit.
- 12 Set production packer at 7110' with EOT @ 7960'. PT backside to 1000 psi.
- 13 ND BOP. NU WH. Ensure wellhead and all valves are rated to 5000 psi.
- 14 Return well to production team.
