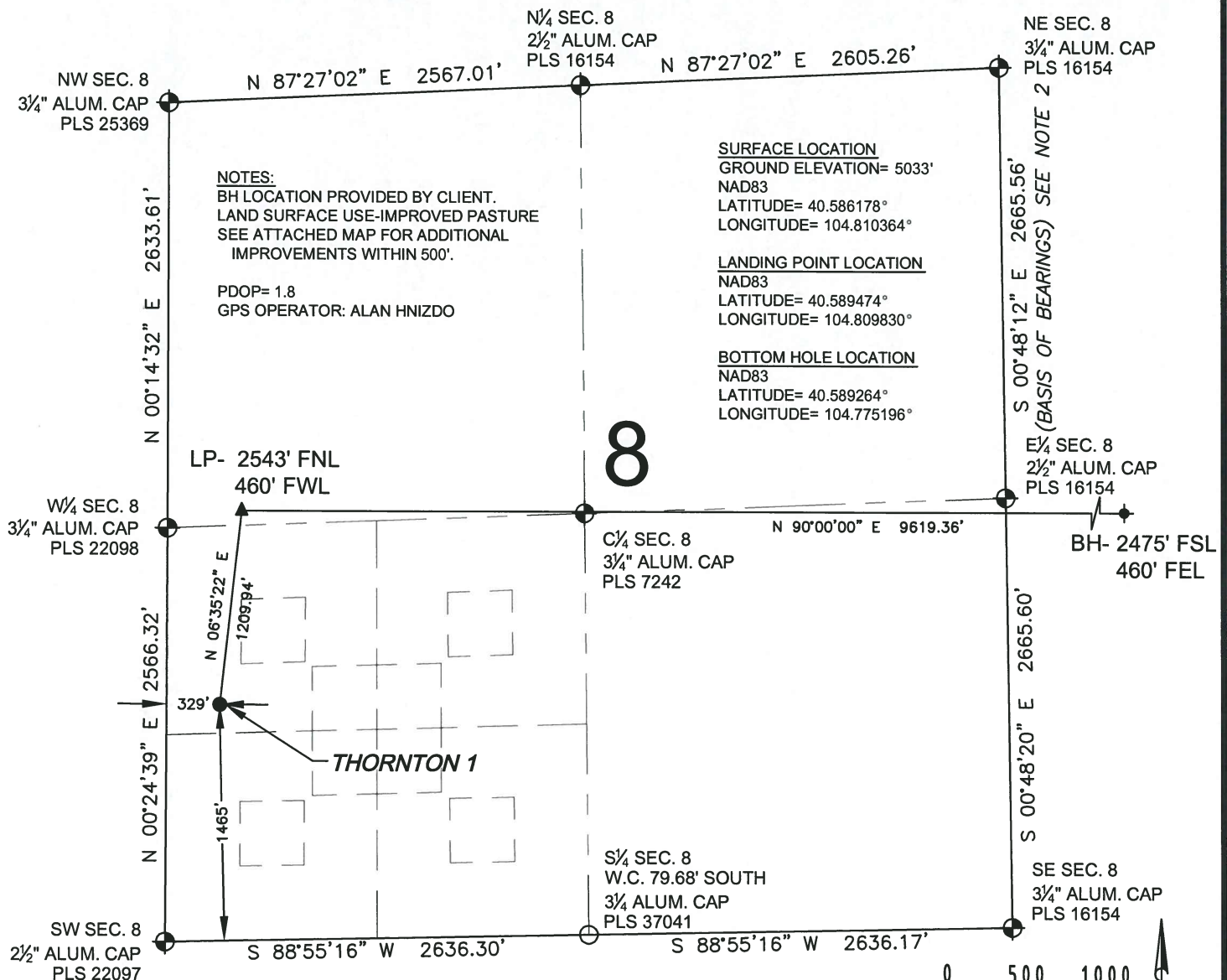


WELL LOCATION CERTIFICATE: THORNTON 1

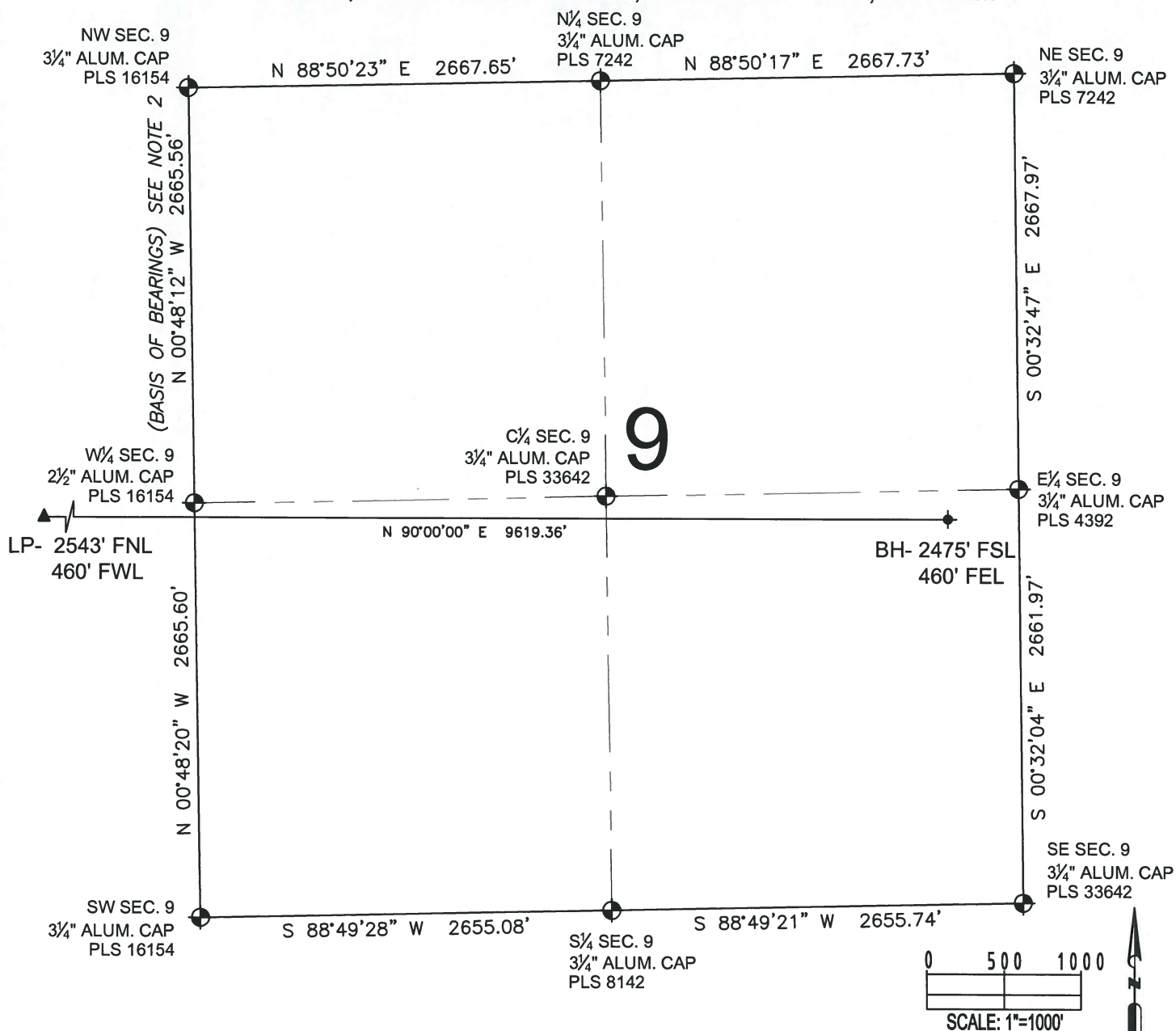
