- 8) RU cement crew, pump 360 sxs 15.8 ppg "G" neat cement to cover the interval 792' - 1792'
- 9) POOH with 1 1/4" tubing, land casing.
- 10) SI well overnight, run CBL recording new cement depths
- 11) Clean out hole and consult work schedule for direction regarding leaving plug, setting packer, or changing the wellhead
