OPERATOR COMMENTS AND SUBMITTAL

Comments Railroad is more than 5,280 feet from site. There are no visible improvements within 500 feet of site except pivot irrigation towers at 421 feet, 238 feet, and 54 feet southwest of location and 129 feet and 310 feet northeast of site. Nearest water well is 2,195 feet from site (Receipt:9054705 Permit:29581- - Use: Domestic). The location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COA's are needed for this location. A pump jack may be necessary to place on facility in the future to help with gas production. It will require either a gas or electric motor to run the pumping jack unit, which will be determined at the time of installation.
