COMMENTS:

The following information summarizes monitoring well installation activities and subsequent groundwater sampling activities that were completed on June of 2014.

On June 17, 2014 a Simco 9100 air rotary rig was used to drill five monitoring wells in an effort to investigate and delineate potential impacts to groundwater downgradient of a release that occurred on March 21, 2014. The well location map is attached.

All wells were drilled to a total depth of 25 feet. No evidence of hydrocarbon impact was observed from the entire drilling interval. 20 feet of screen was installed beginning at 5 feet bgs to the total depth of 25 feet bgs (see attached well log and completion diagrams).

On June 26, 2014, depth to groundwater ranged between 18.03' in MW2 and 18.55' in MW 5. Analytical results indicate no hydrocarbons present above the COGCC allowable concentrations.

The groundwater sampling will be conducted over four consecutive quarters to ensure that BTEX concentration at the Cough 14-22 MV are below the COGCC Table 910-1 standards. Once four quarters of clean data is collected, WPX will request a closure of this remediation project.
