Callie,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

- 1) You have indicated there will be one Modular Large Volume Tank (MLVT) on this oil and gas location. As part of the COGCC Policy on the Use of MLVTs in Colorado the following additional information is required to be on the Form 2A:
 - A) Manufacturer or vendor of the MLVT
 - B) Size/volume of the MLVT
 - C) Anticipated timeframe the MLVT will be onsite
 - D) Operator's certification that the MLVT will be designed and implemented consistent with the policy.
- 2) In the Construction section you have indicated the size of the location after interim reclamation will be 0.0 acres. I suspect this is a typo. Please provide me with a revised size.
- 3) Because the nearest building of any type is the High Occupancy Building Unit identified as 1,047 feet from the proposed oil and gas location, I would like to change the distance to the nearest Building to match it. Also, there are currently no Designated Outside Activity Areas in Weld County. Therefore I will change that distance to 5,280 feet.
- 4) A review of your Location Drawing indicates a portion of the disturbed area will overlap onto the 32-Kim loam, 1-3 percent slopes NRCS Soil Map Unit. Therefore, please provide me that NRCS Soil Map Unit Description.
- 5) In the Water Resources section you have indicated the nearest downgradient surface water feature is 219 feet. Due to the proximity of surface water features to this proposed oil and gas location, I would like to change the Sensitive Area designation to YES.
