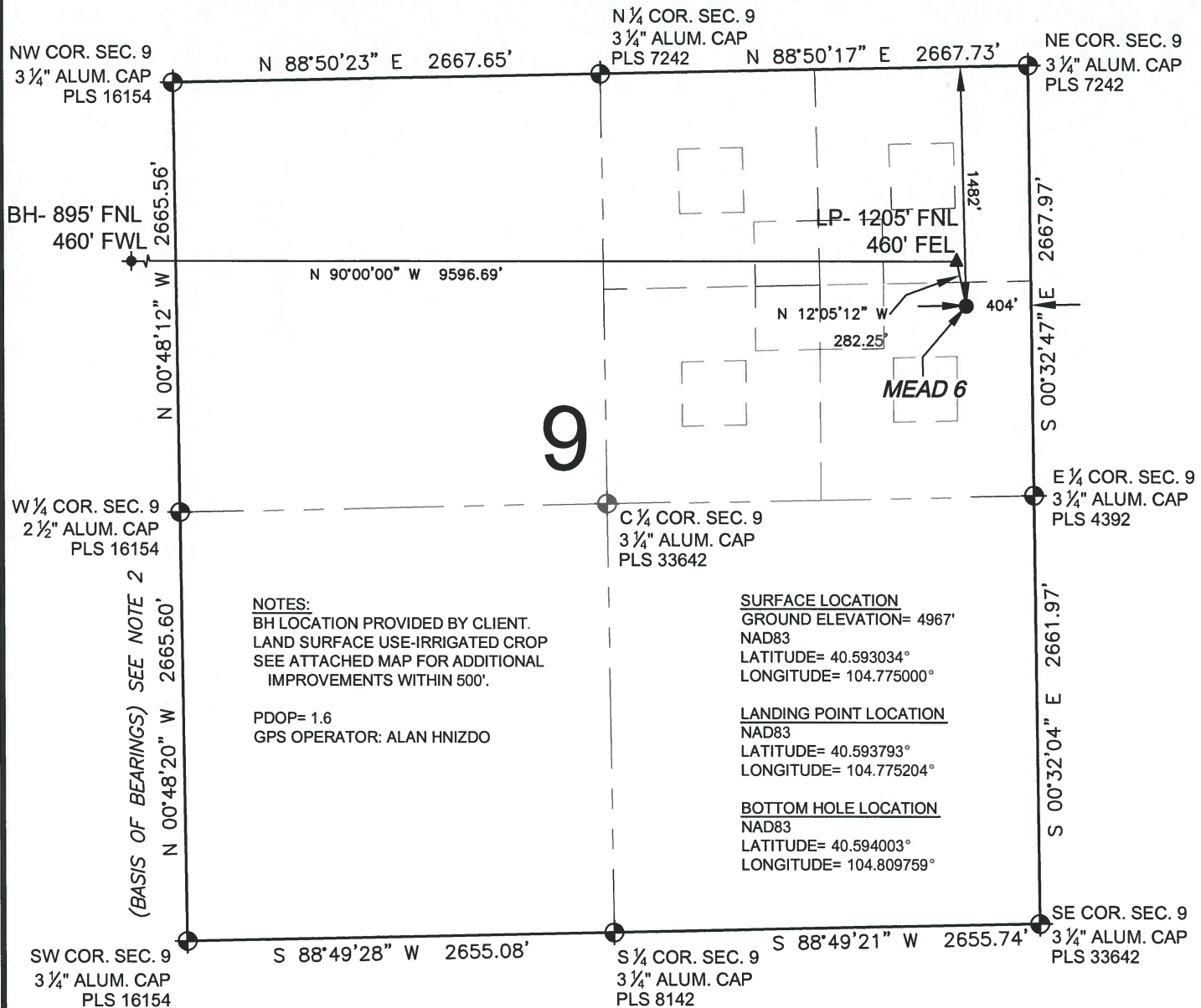


WELL LOCATION CERTIFICATE: MEAD 6

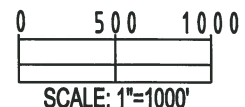

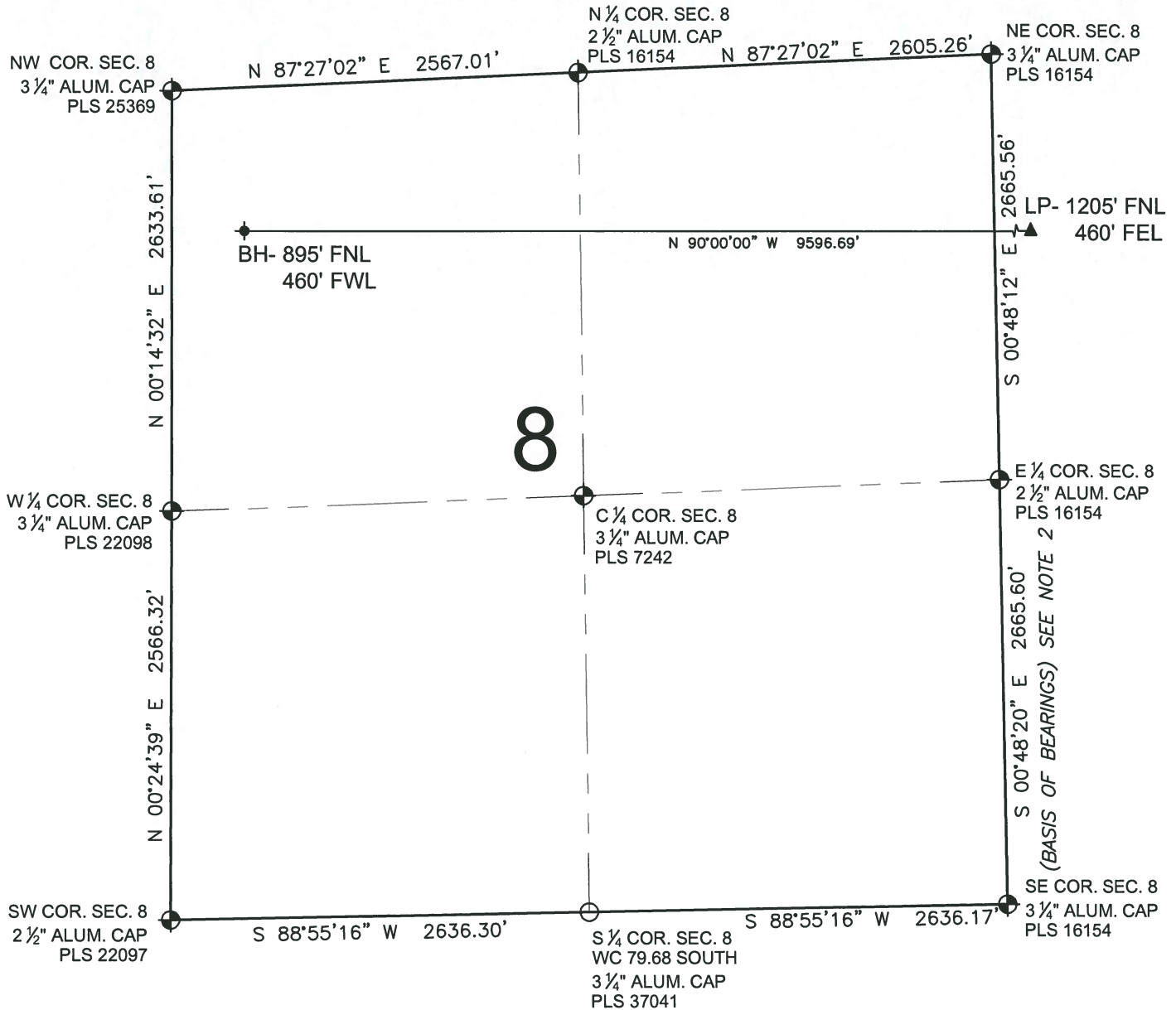
