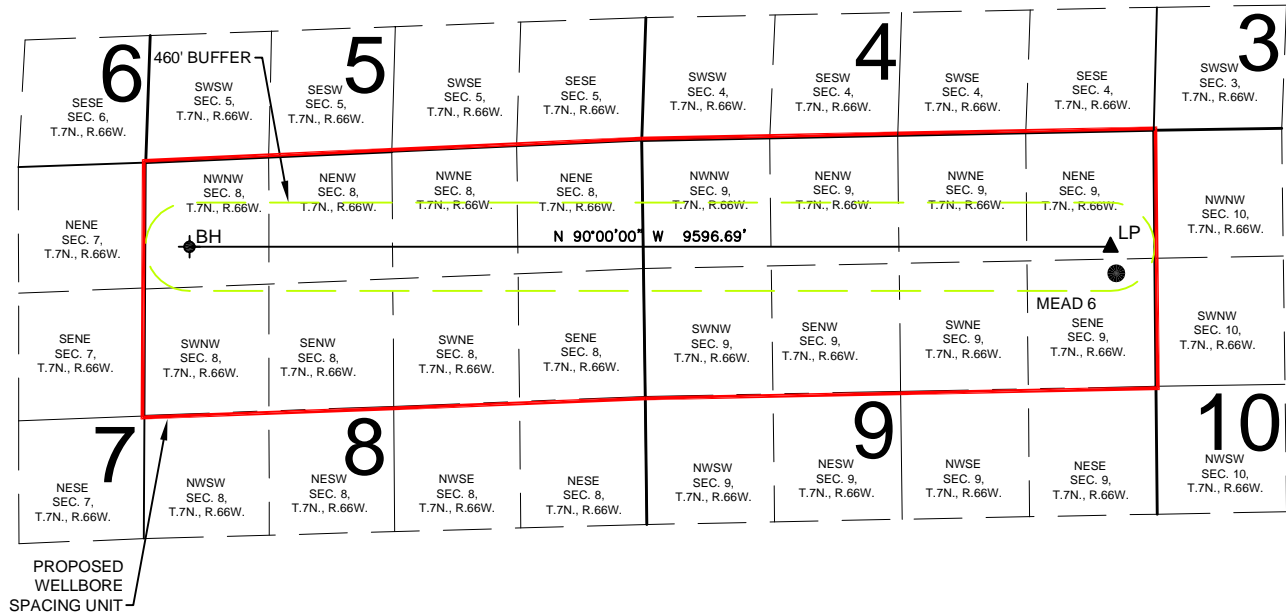

LANDING POINT LOCATION

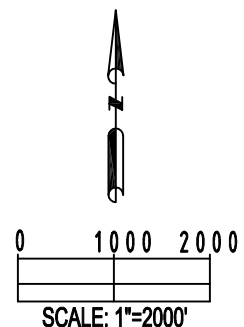
