Containing 640 acres more or less

Extraction is not the only owner within the proposed wellbore spacing unit and has provided notice to the remaining owners within this spacing unit, as required by COGCC Rule 318A.e.(6). The required thirty (30) day notice period has elapsed absent the receipt by Extraction of any objection to their proposal by the owners within the proposed spacing unit for the subject well.

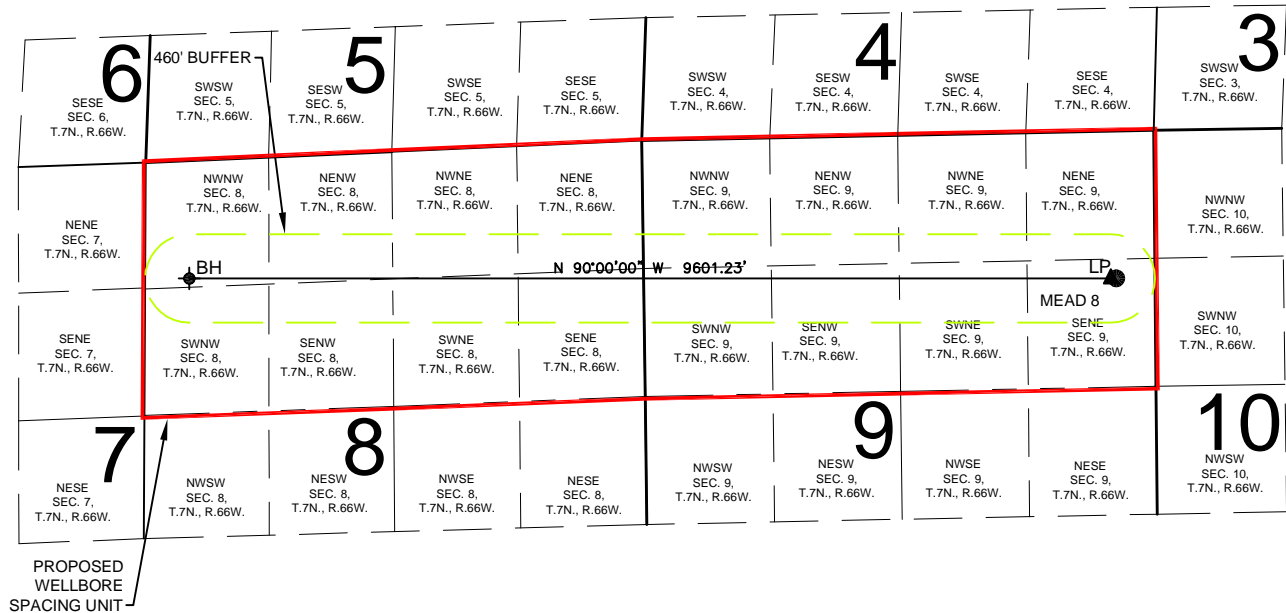

### LANDING POINT LOCATION

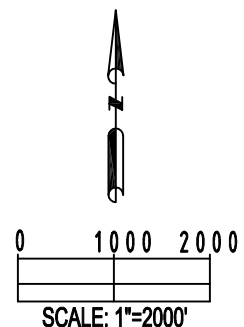
