#### COMMENTS:

A complete gas sample analysis is attached.

Gas was flared for 14 days during a 30-day period beginning June 17, 2014. The average flaring volume during this period was 113.5 MCF/D; volumes were measured daily. A pipeline connection was established on June 18, 2014, and gas has been flowing to sales. Frequency of flaring will decrease as the flowback and maintenance phase of the well is completed.

There is a presence of H2S; sampling showed 2ppm.
