#### COMMENTS:

The current maximum allowable injection volume for the SWD 1-8B is 10,092,800 bbls based on a 1/4 mile radius around the wellbore. At the current injection rates, the maximum injection volume will be reached within the next 8 months.

NGL Water Solutions respectfully requests that the maximum injection volume be increased to 40,371,200 bbls based on a 1/2 mile radius.

Currently, the SWD 1-8B goes on a vacuum when the well is shut-in. There are no other wells within a 1/2 mile radius of the SWD 1-8B that are completed in the same intervals as the SWD 1-8B.
