6. RIH and Shoot squeeze holes @ 7120'.
7. RIH and set CICR @ 7100'
8. RIH and sting into CICR.
9. Attempt to establish injection. If unable to establish injection Call Production Engineer @ 720-261-2295 for path forward.
10. Pump 200 sxs of class G neat cement.
11. Ensure that all cementing work complies with COGCC rule 317.i (listed on previous page)
12. Run CBL and log from top of CICR to surface.
13. RD E-line.
14. POOH with work string.
15. RIH and land lubing above CICR
16. ND BOP, NU wellhead.
17. RDMO Workover rig.
