Per the Mamm Creek NTO, this Form 4 Sundry is being submitted as a Request to Complete for the subject well. Ursa has frac crews scheduled for approximately August 11, 2014. Please find attached the required CBL and Bradenhead Pressure Record. Revised formation tops and top of cement are provided in the Operator Comments section. Temp Logs have been submitted via Form 4 Sundry (Doc # 400644433 - approved July 15th). Ursa received approval from COGCC Engineer, Jay Krabacher, on July 15th, to defer running the CBL on the subject well per Mamm Creek NTO policy. Ursa plans for an eight stage completion to TOG.
