Extraction Oil and Gas, LLC (Extraction) is planning to drill the above referenced well in accordance with the provisions set out in COGCC Rule 318A.e. Extraction's proposed wellbore spacing unit consists of:

Extraction is not the only owner within the proposed wellbore spacing unit and has provided notice to the remaining owners within this spacing unit, as required by COGCC Rule 318A.e.(6). Copies of the required notification letters are on file at Extraction's office. The required thirty (30) day notice period has elapsed absent the receipt by Extraction of any objection to their proposal by the owners within the proposed spacing unit for the subject well.



**WELL MEAD 2 TO BE LOCATED 1378' FNL AND 403' FEL, SEC. 9, T7N, R66W**


