COMMENTS:

Well was drilled to a depth of 6433' and 7" intermediate casing was run. During the cementing of the 7" the cement set up in the casing and did not get fully displaced as planned. Calculations did indicate that the cement top should be more than 200' above the top of the Niobrara and this was later verified by a CBL on 8/6/2014. TOC is 5720' MD, 5712' TVD. This is 333' MD, 264' TVD above the Niobrara.

Procedure

In order to protect the 7" casing from the Parkman formation the plan is to squeeze cement from below the base of the Parkman to the surface. The procedure will be to set a RBP below 4000' and shoot squeeze holes at 3700', establish circulation and pump enough cement to get returns to the surface, leaving 200' inside the 7". The well will then be shut in and pressure will be applied to squeeze 100' of the cement into the squeeze holes, leaving the well shut in overnight. The following morning the cement will be tagged, pressure tested and then drilled out. The casing will then be pressure tested.
